TRADEMARK ASSIGNMENT

This TRADEMARK ASSIGNMENT ("Assignment"), effective as of the 22nd day of June, 2021 (the "Effective Date"), is made and entered into by and between *Saks & Company LLC*, a Delaware limited liability company ("Assignor") and *Street-Works Development LLC*, a Delaware limited liability company ("Assignee"). Assignor and Assignee are collectively referred to herein as the "Parties" and individually as a "Party".

For good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged and agreed, the Parties agree as follows:

1. Assignment. Assignor hereby assigns, sells, conveys, transfers and delivers to Assignee, and Assignee hereby accepts and assumes from Assignor, all of Assignor's rights, title and interests in, to and under the trademark set forth on Exhibit "A" hereto (the "Mark"), together with the goodwill of the business symbolized by and associated with the Mark, including, without limitation, all registrations, applications, renewals, extensions, continuations, divisions, or reissues of the Mark, all common law or unregistered rights in and to the Mark, and all rights of action accrued and to accrue under and by virtue thereof, including, without limitation, the right to sue and recover for past, present and future infringement and misappropriation of the Marks.

2. Recordation. Assignor hereby authorizes and requests the U.S. Commissioner of Patents and Trademarks, and any other official throughout the world whose duty it is to register and record ownership in trademark registrations and applications, to record this Assignment, as to the assigned Mark.

3. Severability. Should any provision or provisions of this Assignment be held by an arbitrator or a court of competent jurisdiction to be illegal, invalid or unenforceable, such provision or provisions may be modified by such court or arbitration panel in compliance with the law and, as modified, enforced. All other terms and conditions of this Assignment shall remain in full force and effect and shall be construed in accordance with the modified provision or provisions, as if such illegal, invalid or unenforceable provision or provisions had not been contained herein.

4. Successors and Assigns. This Assignment will be binding upon and enforceable against Assignor and its successors and assigns and will inure to the benefit of and be enforceable by Assignee and its successors and assigns.


5. Governing Law. This Assignment will be governed by, and construed and enforced in accordance with, the laws of the State of New York, without regard to its principles of conflicts of laws.


