DECLARATION UNDER 37 CFR § 2.20

I, Peter Ebright, declare that:

1. I am General Counsel of **World Yacht L.L.C.**, a Delaware limited liability company ("Current Owner"), and I am making this declaration confirming the termination of a security interest related to a loan agreement executed by **World Yacht II**, a New York general partnership ("Borrower"), and **Girzentrale Und Bank Der Oesterreichischen Sparkassen AG**, an Austrian Aktiengesellschaft ("Lender"), on November 22, 1988, establishing a secured loan (the "Loan") from Lender to Borrower.

2. The Borrower's currently live U.S. trademark registrations identified on attached **Schedule A** ("Borrower's Marks") were secured as collateral for the Loan.

3. On November 21, 1988, a security interest notice was filed and recorded in the U.S. Patent and Trademark Office ("USPTO") at Reel No. 0625 and Frame No. 0662 in the USPTO Assignments Division to perfect and record the Lender's interest in the Borrower's Marks as collateral.

4. The Current Owner is now the current owner of the Borrower's Marks.

5. Current business, financial and legal personnel at the Current Owner have conducted a review of the Current Owner's and the Borrower's available books and records for information on the loan and its history and from the collective knowledge, interpretation and recollection of said personnel, based on and upon information and belief, it is represented that:

- The Loan has been satisfied in full by Borrower and Borrower has been released by Lender from any and all debts and liabilities to Lender;
- Any and all obligations and relationships between Lender and Borrower have been terminated and no longer exist; and

- This declaration is being provided to reflect the foregoing in the USPTO chain of title records for the Borrower's Marks.

6. The security interests in the Borrower's Marks identified on Schedule A granted by Borrower to Lender as collateral for the Loan to Borrower have been terminated and released due to Borrower's full payment and satisfaction of the Loan.

7. The security interests recorded at Reel No. 0625 / Frame No. 0662 in the USPTO have been and remain terminated and are of no legal effect.
