**TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS**

THIS TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS (this “Termination and Release”), dated as of June 23, 2021, by Guggenheim Credit Services, LLC, as collateral agent (in such capacity, the “Collateral Agent”).

WITNESSETH:

WHEREAS, pursuant to certain Trademark Security Agreements recorded with the Trademark Division of the United States Patent and Trademark Office on January 21, 2020 and February 12, 2021, at Reel/Frame 6842/0024 and Reel/Frame 7192/0407 (the “Trademark Security Agreements”), a lien on and security interest (the “Security Interest”) was granted by Fairbanks Morse, LLC and Ward Leonard CT LLC (collectively, the “Grantors”) to the Collateral Agent in certain collateral, including but not limited to the trademarks set forth on Schedule 1 hereto (the “Trademarks”);

WHEREAS, the Collateral Agent now desires to terminate and release the entirety of its Security Interest in the Trademarks;

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, and upon the terms set forth in this Termination and Release, the Collateral Agent hereby agrees as follows:

1. Definitions. Capitalized terms not defined herein shall have the meanings set forth in the Trademark Security Agreements.
2. Release of Security Interest. The Collateral Agent, without representation, warranty or recourse, hereby terminates the Trademark Security Agreements and terminates, releases and discharges any and all Security Interest in the Trademarks, and any right, title or interest of the Collateral Agent in such Trademarks shall hereby cease and become void.
3. Recordation. The Collateral Agent authorizes each Grantors and its designees to record this Termination and Release with the United States Patent and Trademark Office or any other applicable governmental authority at such Grantor’s expense.
