ASSIGNMENT AND ASSUMPTION OF TRADEMARKS

This **ASSIGNMENT AND ASSUMPTION OF TRADEMARKS** (“Assignment”) is entered into as of May 20, 2021 (“Assignment Date”) by and between Foresold LLC, an Arizona limited liability company (“Seller”) and Snow Cosmetics LLC, a Delaware limited liability company (“Buyer”) (Buyer and Seller collectively “Parties”, and each individually “Party”).

RECITALS

WHEREAS, Seller desires to sell and Buyer desires to purchase those certain trademarks all known as “Snow”, which are listed in Exhibit A (collectively, “Trademarks”).

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Parties hereby as follows:

1. Assignment and Assumption. As of the Assignment Date, Seller assigns, transfers, and conveys to Buyer, and Buyer hereby accepts all of the Seller’s right, title, and interest in and to the Trademarks with the goodwill of the business in which they are used. Buyer hereby assumes the obligations of the Trademarks arising from and after the Assignment Date and shall indemnify Buyer shall indemnify Seller from and against any liability, damages, causes of action, and expenses (including attorneys’ fees and costs) that accrue after the Assignment Date with respect to the Trademarks. Seller shall indemnify Buyer from and against any liability, damages, causes of action, and expenses (including attorneys’ fees and costs) that accrued prior to the Assignment Date with respect to the Trademarks.


2. Counterparts. This Assignment may be executed simultaneously in two or more counterparts each of which shall be deemed an original, and all of which, when taken together, constitute one and the same document.

3. Successors. This Assignment shall inure to the benefit of, and be binding upon, the Parties hereto and their respective successor and assigns.


