CONFIRMATORY TRADEMARK ASSIGNMENT

WHEREAS, SNKSTR LLC (“SNKSTR LLC”), an Illinois limited liability company having a principal place of business at 120 North LaSalle Street, Suite 2000, Chicago, Illinois 60602, owns common law rights and associated goodwill in the trademark “SNKSTR” and is the record owner of U.S. Trademark Application No. 88/676,035 for “SNKSTR,” filed on October 31, 2019, for goods in International Class 35 (collectively, SNKSTR LLC’s rights and goodwill in SNKSTR are referred to as the “SNKSTR Mark”);

WHEREAS, Nike, Inc., is an Oregon corporation having its principal place of business at One Bowerman Drive, Beaverton, Oregon 97005 (“NIKE”); and

WHEREAS, pursuant to an Agreement between SNKSTR LLC and NIKE, SNKSTR LLC assigned to NIKE all rights, title, and interest in and to the SNKSTR Mark and the goodwill of the business symbolized thereby (hereafter, the “Agreement”);

WHEREAS, the Parties desire to confirm herewith the terms of the assignment from SNKSTR LLC to NIKE;

NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby mutually acknowledged, SNKSTR LLC hereby confirms the terms of its Agreement in which it sold, assigned, transferred, and conveyed to NIKE all rights, title, and interest in and to the SNKSTR Mark and the goodwill of the business symbolized thereby, including but not limited to U.S. Trademark Application No. 88/676,035.

SNKSTR LLC further confirms the assignment to NIKE of all right to sue for and receive all remedies, including damages, accruing from past infringements of the rights herein assigned.

This assignment shall be binding upon the Parties, their successors, and/or assigns and all others acting by, through, with or under their direction, and all those in privity therewith. This Assignment confirms that the Effective Date of this Assignment is April 28, 2021.
