## RELEASE OF TRADEMARK SECURITY INTEREST

THIS RELEASE OF TRADEMARK SECURITY INTEREST (the “Release”) is made as of June 23, 2021 (the “Effective Date”), by and from The Northwestern Mutual Life Insurance Company, in its capacity as Administrative Agent for itself and the other Lender Parties (together with its successors in such capacity, “Grantee”), with offices at 720 East Wisconsin Avenue, Milwaukee, WI, 53202 and Mar-Cone Appliance Parts Co., a Missouri corporation with offices at One City Place, Suite 400, Saint Louis, MO 63141 and SwiftLink Limited, a Missouri corporation with offices at One City Place, Suite 400, Saint Louis, MO 63141 (each, a “Grantor,” and together, “Grantors”). All capitalized terms used but not otherwise defined herein have the meanings given to them in the Trademark Security Agreement (as defined below).

WHEREAS, Grantors have entered into a Pledge and Security Agreement, dated January 2, 2019 (as amended, restated, amended and restated supplemented, or otherwise modified from time to time, the “Security Agreement”) in favor of Grantee;

WHEREAS, the Grantors executed and delivered that certain Trademark Security Agreement dated as of January 2, 2019 (the “Trademark Security Agreement”), pursuant to which each Grantor granted Grantee a continuing security interest (the “Security Interest”) in all such Grantor’s right, title and interest in and to the Trademarks listed on Schedule A, attached hereto (the “Trademarks”);

WHEREAS, the Trademark Security Agreement was recorded with the United States Patent and Trademark Office on January 2, 2019 at Reel 6515 Frame 0277; and

WHEREAS, the Grantee and the Grantors acknowledge that the requirements for releasing the Security Interest in the Trademarks have now been met.

NOW, THEREFORE, for good and valuable consideration, receipt and sufficiency of which are hereby acknowledged, Grantee hereby (a) terminates and cancels the Trademark Security Agreement, (b) releases, terminates, cancels, relinquishes and discharges the Security Interest in and any right of set off against, the Trademarks, including, without limitation, the Trademarks listed in Schedule A (attached hereto), including any all rights to sue for past, present, and future infringements thereof, and retransfers and (c) reassigns any and all right, title and interest it may have in and to the Trademarks, to the applicable Grantors, without recourse. Grantee authorizes and requests that the U.S. Patent and Trademark Office note and record the existence of the release hereby given.


