**TERMINATION AND RELEASE OF
INTELLECTUAL PROPERTY SECURITY AGREEMENT**

This TERMINATION AND RELEASE dated as of June 23, 2021, from Société Générale (as successor-in-interest to Goldman Sachs Lending Partners LLC), as administrative agent (the “Administrative Agent”), to Osmose Utilities Services, Inc. (the “Grantor”).

WHEREAS, pursuant to that certain Intellectual Property Security Agreement, dated as of January 23, 2019, between the Grantor and the Administrative Agent (as amended, restated, amended and restated, supplemented or otherwise modified or replaced from time to time, the “IP Security Agreement (Trademarks)”), the Grantor granted to the Administrative Agent, for the benefit of the Secured Parties, a continuing security interest in all of Grantor’s right, title and interest in, to and under the Collateral (as defined therein), including those trademarks listed on Schedule A.

WHEREAS, pursuant to that certain Intellectual Property Security Agreement, dated as of January 23, 2019, between the Grantor and the Administrative Agent (as amended, restated, amended and restated, supplemented or otherwise modified or replaced from time to time, the “IP Security Agreement (Patents)”), the Grantor granted to the Administrative Agent, for the benefit of the Secured Parties, a continuing security interest in all of Grantor’s right, title and interest in, to and under the Collateral (as defined therein), including those patents listed on Schedule B.

WHEREAS, the IP Security Agreement (Trademarks) was recorded in the United States Patent and Trademark Office on January 24, 2019, at Reel/Frame 6535/288, and the IP Security Agreement (Patents) was recorded in the United States Patent and Trademark Office on January 24, 2019, at Reel/Frame 48122/662;

NOW, THEREFORE, for good and valuable consideration, the receipt and adequacy of which are hereby acknowledged, the Administrative Agent hereby terminates the IP Security Agreement (Patents) and IP Security Agreement (Trademarks) and terminates, releases and discharges, without recourse, representation or warranty, its security interest in the Collateral, and all right, title, and interest of the Administrative Agent in, to and under such Collateral shall hereby cease and become void.

THIS TERMINATION AND RELEASE AND ANY CLAIM, CONTROVERSY OR DISPUTE (AT LAW OR IN EQUITY) OR OTHERWISE, SHALL BE GOVERNED BY AND CONSTRUED IN ACCORDANCE WITH, THE LAWS OF THE STATE OF NEW YORK.
