## RELEASE OF SECURITY INTEREST IN TRADEMARKS

This **RELEASE OF SECURITY INTEREST IN TRADEMARKS**, dated as of June 25, 2021 (the "Release"), is made by WILMINGTON TRUST, NATIONAL ASSOCIATION, as collateral agent (in such capacity, together with its successors and permitted assigns, the "Collateral Agent") for the Secured Parties, in favor of AVENGER FLIGHT GROUP, LLC, a Florida limited liability company and Papi Flight Training, LLC (the "Grantors"). All capitalized terms used but not otherwise defined herein have the meanings assigned to them in the Guaranty and Security Agreement (as defined below).

### WITNESSETH

WHEREAS, the Grantors, the Collateral Agent, and other parties thereto entered into that certain Pledge and Security Agreement, dated as of September 25, 2019 (as amended, restated, amended and restated, supplemented and/or otherwise modified from time to time, the "Pledge and Security Agreement");

WHEREAS, pursuant to the Pledge and Security Agreement, the Grantors executed the Trademark Security Agreement, dated as of September 25, 2019 (the "Trademark Security Agreement") and recorded with the U.S. Patent and Trademark Office on September 26, 2019 at Reel/Frame No. 6755/0016, pursuant to which the Grantors pledged and granted to the Collateral Agent for the ratable benefit of the Secured Parties, a security interest in all right, title and interest of Grantors in the Trademark Collateral (as defined in the Trademark Security Agreement).


WHEREAS, the Grantors has requested that the Collateral Agent release its security interest in all right, title and interest in, to and under the Trademark Collateral.

NOW, THEREFORE, in consideration of the foregoing, the Collateral Agent hereby DISCHARGES, TERMINATES and RELEASES, without recourse, representation or warranty, its security interest in all right, title and interest in, to and under all of the Trademark Collateral, including the trademark registrations set forth in Schedule I attached hereto and incorporated herein by reference, and agrees that all the security interest in the Trademark Collateral is hereby discharged, terminated and released. The undersigned hereby transfers and assigns to the Grantors, without recourse, representation or warranty, any and all right, title and interest that the Collateral Agent may have obtained in, to and under the Trademark Collateral under the Pledge and Security Agreement and the Trademark Security Agreement.
