RELEASE OF SECURITY INTEREST IN TRADEMARKS

This RELEASE OF SECURITY INTEREST IN TRADEMARKS (this "Release"), dated as of April 28, 2021 (the "Effective Date"), is made by Arvest Bank, an Arkansas banking corporation (the "Bank"), in favor of National Steak Processors, LLC, a Delaware limited liability company, Boyle's Famous Corned Beef, LLC, a Delaware limited liability company and Hausman Foods, LLC, a Delaware limited liability company (each a "Grantor", and collectively, the "Grantors").

WHEREAS, the Bank and the Grantors are successor parties to an Amended and Restated Trademark Security Agreement dated November 30, 2018 (the "Security Agreement"), recorded with the United States Patent and Trademark Office (the "USPTO") at Reel/Frame 006492/0099 on November 30, 2018, which was entered into pursuant to a Credit Agreement (as defined in the Trademark Security Agreement) between the Bank and the Grantors, and under which each Grantor granted to Bank a security interest in and to certain collateral;

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Agent hereby agrees as follows:

1. Release. The Bank without representation or warranty of any kind, hereby releases, discharges, terminates and cancels (to the extent not previously released, discharged, terminated and cancelled), all of its security interest in and to the collateral arising under the Security Agreement, including any amendments thereto and restatements thereof (the "Security Agreement"), including the trademark registrations and applications set forth in Exhibit A attached hereto (collectively the "Trademark Collateral"). If and to the extent that the Bank has acquired any right, title or interest in and to the Trademark Collateral under the Trademark Security Agreement, the Bank, without representation or warranty of any kind, hereby re-transfers, re-conveys and re-assigns such right, title or interest to the Grantors.

3. Termination. The Bank, without representation or warranty of any kind, terminates and cancels the Security Agreement.

4. Further Assurances. The Bank agrees to take all further actions, and provide to the Grantors and its successors, assigns or other legal representatives, all such cooperation and assistance (including, without limitation, the execution and delivery of any and all documents or other instruments), reasonably requested by the Grantors, at the Grantors' sole cost and expense, to more fully and effectively effectuate the purposes of this Release.



5. Governing Law. This Release shall be governed exclusively under the laws of the State of Kansas, without regard to conflicts of law or choice of law principles.
