WHEREAS, pursuant to (a) that certain Amended and Restated Credit Agreement dated as of November 21, 2017 (as amended, restated, supplemented, or otherwise modified from time to time prior to the date hereof, the "Credit Agreement"), by and among MUD PIE, LLC, a Delaware limited liability company ("Opco"), JUDD MILLER HOLDING CORPORATION, a Georgia corporation ("Holdco", Opco and Holdco are referred to therein each as a "Borrower" and, collectively as the "Borrowers"), the several banks and other financial institutions and lenders from time to time party thereto (the "Lenders"), and TRUIST BANK, in its capacity as Administrative Agent for the Lenders, as the Issuing Bank, and as the Swingline Lender, (b) the Guaranty and Security Agreement dated as of May 4, 2015 (as amended, supplemented or otherwise modified from time to time, the "Guaranty Agreement"), among the Borrowers, the other grantors from time to time party thereto and the Administrative Agent, and (c) that certain Trademark Security Agreement, dated as of May 4, 2015 (as amended, supplemented or otherwise modified from time to time, the "Trademark Security Agreement"), executed by the Grantor in favor of the Administrative Agent, the Grantor pledged and granted to the Administrative Agent a security interest in and continuing lien on all of Grantor's right, title and interest in, to and under the Trademark Collateral (as defined in the Trademark Security Agreement), including the Trademarks listed on Schedule 1 attached hereto; and

The Administrative Agent hereby (i) terminates the Trademark Security Agreement, (ii) terminates, releases and discharges all of its mortgages, liens, and security interests in all of each Grantor's right, title and interest in, to and under all of such Grantor's United States Trademarks, including, but not limited to, the Trademark applications and Trademark registrations referred to in <u>Schedule 1</u> attached hereto (the "<u>Trademark Collateral</u>") and (iii) reassigns any and all such right, title and interest (if any) that the Administrative Agent may have in the Trademark Collateral to such Grantor.
- 2. The Administrative Agent authorizes and requests that the United States Patent and Trademark Office and any other applicable officer in any successor office or any similar office in any other country record this Release.

3. THIS RELEASE AND THE RIGHTS AND OBLIGATIONS OF THE PARTIES UNDER THIS RELEASE SHALL BE CONSTRUED IN ACCORDANCE WITH AND GOVERNED BY THE LAW OF THE STATE OF GEORGIA, WITHOUT REGARD TO CONFLICTS OF LAW PRINCIPLES THAT WOULD REQUIRE THE APPLICATION OF THE LAWS OF ANOTHER JURISDICTION.
