TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS

THIS TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS (this "Termination and Release"), dated as of June 25, 2021, is made by **GLAS TRUST CORPORATION LIMITED**, as Security Agent for the Secured Parties (in such capacity, together with its successors and assigns in such capacity, the "Security Agent").

WITNESSETH:

WHEREAS, pursuant to that certain Grant of Security Interest in United States Patents and Trademarks dated as of May 13, 2020 (the "Pledge and Security Agreement") made by **BIDSPOTTER, INC.**, a Delaware corporation ("Bidspotter"), and **PROXIBID, INC.**, a Nebraska corporation ("Proxibid") and together with Bidspotter, collectively, the "Grantors" and each individually, a "Grantor") in favor of the Security Agent, the Grantors granted a lien on and security interest ("Security Interest") to the Security Agent in the Trademarks;

WHEREAS, the Pledge and Security Agreement was recorded with the United States Patent and Trademark Office on May 18, 2020, at Reel/Frame 6941/0739; and

WHEREAS, the Security Agent now desires to terminate and release its Security Interest in the Trademarks, including, without limitation, the Trademarks listed on Schedule A hereto (the "Released Trademarks").

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, and upon the terms set forth in this Termination and Release, the Security Agent hereby agrees as follows:


1. Definitions. Capitalized terms not defined herein have the meanings set forth in the Pledge and Security Agreement.
2. Release of Security Interest. The Security Agent, without representation, warranty or recourse, hereby terminates, releases and discharges any and all Security Interest in the Released Trademarks, and any right, title or interest of the Security Agent in such Released Trademarks shall hereby cease and become void.
3. Recordation. The Security Agent authorizes the Grantors and their designees to, at the Grantors' sole expense, record this Termination and Release with the United States Patent and Trademark Office or any other applicable governmental authority and agrees that, it shall execute all other documents and do all other acts necessary to relinquish and effect the release of such rights in the Released Trademarks to the Grantors.
