**TERMINATION AND RELEASE OF SECURITY INTEREST IN
INTELLECTUAL PROPERTY**

THIS TERMINATION AND RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY, dated as of June [8th], 2021, is made by **THE HUNTINGTON NATIONAL BANK**, as successor to FirstMerit Bank, N.A., in its capacity as administrative agent for the Lenders (as defined below) (together with its successors and assigns in such capacity, "Agent"), under that certain Confirmatory Grant of Security Interest in Intellectual Property, dated as of May 22, 2020, by **CLASSIC ACCESSORIES, LLC**, a Delaware limited liability company ("Classic"), **DUCK COVERS, LLC**, a Delaware limited liability company ("Duck Covers"), and together with Classic, are sometimes hereinafter referred to individually and collectively as "Grantor" and/or "Grantors", in favor of Agent (as amended, restated, supplemented or modified and in effect from time to time, the "IP Security Agreement"). Capitalized terms used but not defined herein shall have the meanings set forth in the IP Security Agreement.

WHEREAS, pursuant to the IP Security Agreement, Grantor granted a security interest to Agent (for benefit of the Lenders) in certain intellectual property collateral including the intellectual property set forth on Exhibit A, Exhibit B, and Exhibit C attached thereto (the "IP Collateral"); and

WHEREAS, Agent has agreed to terminate and release its security interest in all of such IP Collateral.

NOW, THEREFORE, for good and valuable consideration, the receipt of which is hereby acknowledged, Agent does hereby, in each case, without recourse, representation or warranty of any kind whatsoever, (a) terminate the liens and security interest created under the IP Security Agreement in the IP Collateral, (b) release its security interest in the IP Collateral, and (c) discharge any and all rights, title and interest it has in and the security interest granted to Agent in the IP Collateral.


