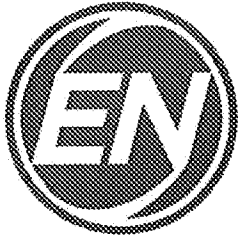

For purposes of this Agreement, the marks shall be referred to as the “Marks.”


Assignee desires to acquire the Marks, the goodwill associated with the Marks, and the federal registrations of the Marks.
