Assignment and Ownership. Assignor hereby transfers, conveys and assigns all of Assignor’s right, title, and interest in and to the Trademarks to Assignee, and Assignor agrees not to challenge the validity of Assignee’s ownership in the Trademarks at any time after the Effective Date hereof. Assignor further transfers, conveys and assigns to Assignee, without any additional consideration, all ownership, right, and interest in and to that portion of the Assignor’s business symbolized by the Trademarks, and all goodwill associated with the foregoing.
