**RELEASE AND TERMINATION  
OF SECURITY INTEREST IN TRADEMARK COLLATERAL**

THIS RELEASE AND TERMINATION OF SECURITY INTEREST IN TRADEMARK COLLATERAL, dated as of June 29, 2021 (this “Release”), is made by HPS INVESTMENT PARTNERS, LLC, a Delaware limited liability company, acting in its capacity as collateral agent for the Secured Parties (in such capacity, the “Collateral Agent”) under that certain Trademark Security Agreement, dated as of October 2, 2020 (as amended, restated, amended and restated, supplemented or otherwise modified and in effect from time to time, the “Trademark Security Agreement”), by CAL-TEX PROTECTIVE COATINGS, INCORPORATED, ROYAL GUARD, L.L.C., PREVENT-A-THEFT GROUP NEVADA, LLC, MOTOR DEALER SERVICES GROUP, LLC, and C.A.R.S. PROTECTION PLUS, INC. (each a “Grantor”) in favor of the Collateral Agent. Capitalized terms used herein without definition are used as defined in the Trademark Security Agreement.

WHEREAS, pursuant to the Trademark Security Agreement, which was recorded in the records of the United States Patent and Trademark Office as set forth on the attached Schedule 2, each Grantor granted to the Collateral Agent a security interest in and continuing lien on all of such Grantors’ right, title and interest in, to and under their owned or thereafter acquired Trademark Collateral, including those Trademarks set forth on the attached Schedule 1;

WHEREAS, pursuant to that certain Payoff Letter, dated as of June 29, 2021, by and among each Grantor, the other signatories party thereto and the Collateral Agent, the Collateral Agent has (a) agreed to release any and all security interests it may have under the Credit Documents (as defined therein), which includes the security interests in the Trademark Collateral pursuant to the Trademark Security Agreement and (b) authorized the recording of this document in the United States Patent and Trademark Office to evidence and effect the release, termination, relinquishment and discharge of its security interest in the Trademark Collateral.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Collateral Agent does hereby, in each case, without recourse, representation or warranty of any kind whatsoever, (a) terminate the security interest created under the Trademark Security Agreement in the Trademark Collateral, (b) release and relinquish its security interest in the Trademark Collateral, and (c) discharge any and all rights, title and interest it has in and the security interest granted to the Collateral Agent in the Trademark Collateral. The Collateral Agent agrees, or authorizes each Grantor, to make filings with the United States Patent and Trademark Office and take further actions, as reasonably requested by any Grantor to evidence the release and termination of the Collateral Agent’s security interests in the Trademark Collateral.

THIS RELEASE SHALL BE GOVERNED BY AND CONSTRUED IN ACCORDANCE WITH THE LAWS OF THE STATE OF NEW YORK.
