**TERMINATION AND RELEASE OF SECURITY INTEREST  
IN TRADEMARK RIGHTS**

TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARK RIGHTS dated as of June 30, 2021, from WILMINGTON TRUST, NATIONAL ASSOCIATION, as Collateral Agent (in such capacity, the "Agent") for the Secured Parties, to CAR WASH PARTNERS, INC., a Delaware corporation and PRIME SHINE, LLC, a California limited liability company (collectively, the "Grantor").

WITNESSETH:

WHEREAS, pursuant to the Second Lien Security Agreement, dated as of May 14, 2019, made by the Grantor (as defined therein) in favor of WILMINGTON TRUST, NATIONAL ASSOCIATION, as the Agent (the "Second Lien Security Agreement"), a security interest (the "Security Interest") was granted by the Grantor to the Agent in certain collateral, including the Trademark Collateral (as hereinafter defined);

WHEREAS, pursuant to that certain Second Lien Trademark Security Agreement dated as of May 14, 2019 among the Agent and Grantor (the "Security Agreement"), Grantor affirmed its intent to grant a Security Interest to the Agent specifically in certain Trademark Collateral;

WHEREAS, the Security Agreement was recorded in the Trademark Division of the United States Patent and Trademark Office on May 15, 2019 at Reel 6645, Frame 0558; and

WHEREAS, the Agent now desires to terminate and release the entirety of its Security Interest in the Trademark Collateral;

NOW, THEREFORE, for good and valuable consideration including the satisfaction of all obligations, indebtedness and liabilities secured by the Trademark Collateral pursuant to the Second Lien Security Agreement, the receipt and adequacy of which are hereby acknowledged, and upon the terms set forth in this Termination and Release, the Agent hereby states as follows:


1. Definitions. The term "Trademark Collateral," as used herein, shall mean all of the Grantor's right, title and interest of every kind and nature as of the date hereof in the Trademarks listed on Schedule A hereto. The term "Trademarks" shall have the meaning provided by reference in the Second Lien Security Agreement.

2. Release of Security Interest. The Agent hereby terminates, cancels, releases and discharges its Security Interest in and lien upon the Trademark Collateral, and any right, title or interest of the Agent in such Trademark Collateral shall hereby terminate, cease and become void.

3. Further Assurances. The Agent hereby agrees to duly execute, acknowledge, procure and deliver any further documents and to do such other acts as may be reasonably necessary to effect the release of the Security Interest contemplated hereby.


