**RELEASE OF SECURITY INTEREST
IN INTELLECTUAL PROPERTY COLLATERAL**

THIS RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY COLLATERAL (this "Release"), dated as of June 30, 2021, is made by Monroe Capital Management Advisors, LLC, a Delaware limited liability company, in its capacity as collateral agent (the "Collateral Agent"), in favor of Stratus Unlimited LLC, formerly MC Sign LLC, a Delaware limited liability company, and Icon Identity Solutions, Inc., an Illinois corporation (collectively, the "Grantors"), as follows:

WITNESSETH:

WHEREAS, pursuant to that certain Guaranty and Collateral Agreement, dated as of December 22, 2017 and that certain Amended and Restated Guaranty and Collateral Agreement, dated as of August 30, 2019 (as amended, supplemented or otherwise modified from time to time, collectively, the "Guaranty and Collateral Agreement"), by and among, inter alios, the Grantors and the other parties party thereto in favor of the Collateral Agent, and those certain agreements described on Annex I attached hereto (the "IP Security Agreements"), the Grantors granted a security interest in certain collateral in favor of the Collateral Agent, including the IP Collateral (as hereinafter defined); and

WHEREAS, the Collateral Agent now desires to terminate and release the IP Security Agreements and the entirety of its security interest in the IP Collateral, including without limitation the IP Collateral described on Annex II attached hereto.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, and upon the terms set forth in this Release, the Collateral Agent hereby agrees as follows:

1. Definitions. The term "IP Collateral", as used herein, shall mean all of the Grantors' right, title or interest in, or to any and all of the Trademark Collateral and Patent Collateral as defined in the IP Security Agreements (including without limitation the IP Collateral listed on Annex II attached hereto). Capitalized terms not defined herein have the meanings set forth in the Guaranty and Collateral Agreement or IP Security Agreements, as applicable.

2. Release of Security Interest. The Collateral Agent, without recourse, representation or warranty, hereby terminates, cancels, releases, relinquishes, re-assigns and discharges, in its entirety, for the benefit of the Grantors, and their successors and assigns, its security interest in and to the IP Collateral (including without limitation the IP Collateral listed on Annex II attached hereto), the IP Security Agreements and any and all right, title and interest of the Collateral Agent in and to the IP Collateral and under the IP Security Agreements shall hereby be terminated, cancelled, released, relinquished, re-assigned and discharged. The Collateral Agent hereby authorizes the Grantors and their successors, assigns or other legal representatives to file this Release with the United States Patent and Trademark Office, to evidence and effectuate the release and termination of the Agent's security interest in the IP Collateral.


