**TERMINATION AND RELEASE OF SECURITY INTEREST  
IN TRADEMARKS**

This **TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS**, dated as of June 30, 2021 (“Release”), is made by The Northwestern Mutual Life Insurance Company, as Collateral Agent (in such capacity, together with its successors and permitted assigns, the “Collateral Agent”) in favor of Ascensus Specialties LLC, a Delaware limited liability company, and Ascensus Specialties Callery LLC (f/k/a Callery, LLC), a Delaware limited liability company (each a “Grantor” and, collectively, the “Grantors”).

**WHEREAS**, pursuant to (a) that certain Second Lien Guaranty and Security Agreement, dated as of September 24, 2019 (as amended, restated, supplemented or otherwise modified from time to time, the “Security Agreement”), in favor of the Collateral Agent, to guaranty the Obligations (as defined in the Credit Agreement), and (b) that certain Trademark Security Agreement, dated as of September 24, 2019 (as amended, restated, supplemented or otherwise modified from time to time, the “Trademark Security Agreement”), by and among the Grantors and Collateral Agent, each Grantor granted to the Collateral Agent, for the benefit of the Secured Parties, a Lien on and security interest in, all of its right, title and interest in, to and under the Trademark Collateral; and

**WHEREAS**, the Trademark Security Agreement was recorded at the United States Patent and Trademark Office (“USPTO”) on October 7, 2019 at Reel 6765 Frame 0167.

**NOW THEREFORE**, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Collateral Agent, on behalf of the Secured Parties, and Grantors agree as follows:

**SECTION 1. Defined Terms.** All capitalized terms used herein but not otherwise defined herein have the meanings given to them in the Security Agreement or Trademark Security Agreement.

**SECTION 2. Termination and Release.** Collateral Agent, on behalf of the Secured Parties, without representation, warranty, or recourse, hereby:

(a) terminates, cancels, discharges, and releases the Lien on and security interest in, all of its right, title and interest in, to and under the Trademark Collateral, including, but not limited to, the foregoing listed on Schedule A attached hereto, granted pursuant to the Security Agreement or Trademark Security Agreement; and


(b) authorizes the recordation of this Release with the USPTO at Grantors’ expense.

**SECTION 3. Governing Law.** THIS RELEASE AND THE RIGHTS AND OBLIGATIONS OF THE PARTIES HERETO SHALL BE GOVERNED BY AND CONSTRUED AND INTERPRETED IN ACCORDANCE WITH THE LAWS OF THE STATE OF NEW YORK.
