**RELEASE OF SECURITY INTEREST IN TRADEMARK COLLATERAL**

This **RELEASE OF SECURITY INTEREST IN TRADEMARK COLLATERAL**, dated as of June 30, 2021 (this "Release"), is made by OWL ROCK CAPITAL CORPORATION, in its capacity as collateral agent for the Secured Parties (in such capacity, the "Collateral Agent"), in favor of LIVESAFE, INC., a Delaware corporation and INDUSTRYSAFE, LLC, a Pennsylvania limited liability company (each a "Grantor" and collectively, the "Grantors"). Capitalized terms used but not otherwise defined herein have the meaning given to them in the Security Agreement.

**WITNESSETH**

WHEREAS, Grantors and the Collateral Agent are parties to that certain First Lien Pledge and Security Agreement, dated as of November 21, 2018 (as amended, restated, amended and restated, replaced, supplemented or otherwise modified, the "Security Agreement");

WHEREAS, pursuant to the Security Agreement, the Grantors executed the First Lien Trademark Security Agreement, dated as of December 4, 2020 (the "Trademark Security Agreement") and recorded with the U.S. Patent and Trademark Office on December 7, 2020 at Reel/Frame Nos. 7125/0150 and 7125/0165, pursuant to which the Grantors pledged and granted to the Collateral Agent, for the benefit of the Secured Parties, a lien on and security interest in and to all of its right, title and interest in, to and under the Trademark Collateral (as defined in the Trademark Security Agreement).

WHEREAS, the Grantors have requested that the Collateral Agent release its security interest in all right, title and interest in, to and under all of the Trademark Collateral.

NOW, THEREFORE, in consideration of the foregoing, the Collateral Agent hereby DISCHARGES, TERMINATES and RELEASES, without recourse, representation or warranty, its security interest in all right, title and interest in, to and under all of the Trademark Collateral, including the trademark registrations and applications set forth in Schedule I attached hereto and incorporated herein by reference, and agrees that all the security interest in the Trademark Collateral is hereby discharged, terminated and released. The undersigned hereby transfers and assigns to the Grantors, without recourse, representation or warranty, any and all right, title and interest that the Collateral Agent may have obtained in, to and under the Trademark Collateral under the Security Agreement and the Trademark Security Agreement.
