TRADEMARK ASSIGNMENT

WHEREAS, Assignor desires to transfer all of its right, title and interest in the Mark together with the goodwill of the business symbolized thereby, and the Registration, and any copyrights therein, to Assignee, and Assignee desires to accept said transfer;

NOW, THEREFORE, for the sum of \$1.00 and other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Assignor, as of the date indicated in the signature line below, assigns and transfers to Assignee, its successors and assigns, absolutely and forever, all of Assignor's right, title and interest in and to the Mark, whether statutory or at common law, including the Registration, and any copyrights therein and any renewals or extensions thereof and all rights of modification thereof, together with the goodwill of the business symbolized by the Mark, and all causes of action for any and all past infringements of the rights so assigned occurring before or after the date of this Assignment and the right to collect and retain the proceeds therefrom, and Assignor agrees to provide Assignee with any documentation, specimens, use evidence, and/or other materials as may be requested from time to time by Assignee to support the recordation of this Assignment and/or maintenance of the Registration of the Mark with the United States Patent and Trademark Office, or any other trademark or copyright office anywhere else, or otherwise to enforce Assignee's rights in the Mark.

In the event Assignee chooses to abandon or sell its rights in the Marks, it is agreed that Assignor shall have the right of first refusal to purchase said rights.
