**RELEASE OF SECURITY INTEREST IN TRADEMARKS**

This RELEASE OF SECURITY INTEREST IN TRADEMARKS (the “Release”) is entered into as of June 29, 2021 (the “Effective Date”), between MANUFACTURERS AND TRADERS TRUST COMPANY, in its capacity as administrative agent and collateral agent for certain agents and other secured parties (in such capacity, together with any successors and assigns, the “Grantee”), DTLR, Inc., a Delaware corporation (“DTLR”) and SNEAKER VILLA, INC., a Delaware corporation (“Sneaker Villa”; and together with DTLR, each a “Grantor” and, collectively, the “Grantors”).

WHEREAS, the Grantee, for the benefit of the Lender Parties, previously was granted a security interest with respect to (i) the Collateral (as defined in the 2017 Trademark Agreement referenced below), including those trademarks as more particularly described in Exhibit A attached hereto (such trademarks and other Collateral, the “2017 Trademark Collateral”), of Sneaker Villa pursuant to a Security Agreement for Trademarks, dated as of August 14, 2017 (as amended, supplemented, reaffirmed, amended and restated or modified from time to time, the “2017 Trademark Agreement”; any capitalized term used but not otherwise defined herein shall have the meaning assigned to such term in the 2017 Trademark Agreement), made by Sneaker Villa, in favor of the Grantee, which agreement was recorded August 14, 2017, with the United States Patent and Trademark Office at Reel 006129, Frame 0439 and (ii) the Collateral (as defined in the 2010 Trademark Agreement referenced below), including those trademarks as more particularly described in Exhibit B attached hereto (such trademarks and other Collateral, the “2010 Trademark Collateral”; and together with the 2017 Trademark Collateral, the “Trademark Collateral”), of DTLR pursuant to a Security Agreement for Trademarks, dated as of December 7, 2010 (as amended, supplemented, reaffirmed, amended and restated or modified from time to time, the “2010 Trademark Agreement”; and together with the 2017 Trademark Agreement, the “Trademark Agreements”; any capitalized term used but not otherwise defined herein shall have the meaning assigned to such term in the Trademark Agreements), made by DTLR, in favor of the Wells Fargo Bank, National Association, which agreement was recorded December 10, 2010, with the United States Patent and Trademark Office at Reel 004429, Frame 0750 and assigned to the Grantee pursuant to the Assignment of Security Agreement for Trademarks, dated as of October 17, 2013, which agreement was recorded October 21, 2013, with the United States Patent and Trademark Office at Reel 005134, Frame 0177; and

WHEREAS, in connection with the full satisfaction and discharge of all obligations secured by the Trademark Agreements, the Grantors have requested that the Grantee release its security interest granted pursuant to the Trademark Agreements in the Trademark Collateral, including all goodwill associated with the Trademark Collateral, and the Grantee (acting on behalf of the Lender Parties) has agreed to do so on the terms and conditions set forth in that certain payoff letter executed by the Grantee and the Grantors contemporaneously herewith.


NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the Grantee (acting on behalf of the Lender Parties) hereby (i) terminates, releases and discharges its security interest and all of its right, title and interests in, to and under the Trademark Collateral and all such right, title and interests are hereby reassigned to

the Grantors, respectively, without representation or warranty of any kind and (ii) authorizes and requests that the United States Commissioner of Patents and Trademarks and any other applicable officer in any successor office or any similar office in any other country record this Release.
