Ladies and Gentlemen:

Reference is hereby made to that certain Revolving Credit, Term Loan and Security Agreement, dated September 3, 2013 (as amended, modified or otherwise supplemented to date, the "**Credit Agreement**") by and among TENON LIMITED, a New Zealand limited company ("**Tenon Limited**"), TENON MANUFACTURING LIMITED, a New Zealand limited company, ("**Tenon Manufacturing**"), TENON INDUSTRIES LIMITED, a New Zealand limited company ("**Tenon Industries**"), together with Tenon Limited, Tenon Manufacturing and each other Person incorporated or organized under the laws of New Zealand joined thereto as a borrower from time to time, collectively the "**NZ Borrowers**", and each individually a "**NZ Borrower**"), TAUPO WOOD SOLUTIONS LLC, a Delaware limited liability company ("**Taupo Wood**"), FLETCHER WOOD SOLUTIONS, INC., a Delaware corporation ("**Fletcher**"), COMANCHE INVESTMENTS, LLC, a Delaware limited liability company ("**Comanche**"), FAIRFIELD ROAD, LLC, a North Carolina limited liability company ("**Fairfield**"), ORNAMENTAL MOULDINGS, LLC, a Delaware limited liability company ("**Ornamental Mouldings**"), ORNAMENTAL PRODUCTS, LLC, a North Carolina limited liability company ("**Ornamental Products**"), SOUTHWEST MOULDING CREATIVE WOOD PRODUCTS, LP, a Texas limited partnership ("**Southwest Wood**"), CREATIVE STAIR PARTS, LLC, a Michigan limited liability company ("**Creative**"), THE EMPIRE COMPANY, LLC, a Michigan limited liability company ("**Empire**"), SOUTHWEST MOULDING CO., LP, a Texas limited partnership ("**Southwest Moulding**"), SOUTHWEST MOULDING TRUCKING CO., LP, a Texas limited partnership ("**Southwest Trucking**"), NOVO BUILDING PRODUCTS, LLC, a North Carolina limited liability company ("**Novo LLC**"), and together with Taupo Wood, Fletcher, Comanche, Fairfield, Ornamental Mouldings, Ornamental Products, Southwest Wood, Creative, Empire, Southwest Moulding, Southwest Trucking and each Person incorporated or organized under the laws of any State of the United States joined thereto as a borrower from time to time, collectively, the "**US Borrowers**" and each individually a "**US Borrower**"), ORNAMENTAL MOULDINGS COMPANY, a Nova Scotia unlimited liability company ("**Ornamental CN**"), and THE EMPIRE CANADA COMPANY LTD., an Ontario corporation ("**Empire CN**"), and together with Ornamental CN and each Person incorporated or organized under the laws of Canada joined thereto as a borrower from time to time, the "**Canadian Borrowers**"; the Canadian Borrowers, together with the NZ Borrowers, the US Borrowers and (if any) the Australian Borrowers, and each other Person joined thereto as a borrower from time to time, collectively, the "**Borrowers**"), PNC Bank, National Association ("**PNC**"), as a Revolving Lender and as a Term Loan Lender, the financial institutions which are now or hereafter become a party thereto (together with PNC, collectively, the "**Lenders**" and each individually a "**Lender**") and PNC, as agent for Lenders (PNC, in such capacity, "**Agent**"). Initially capitalized terms used herein without definition shall have the meanings given in the Credit Agreement. Borrowers have informed Agent that Borrowers desire to terminate the Credit Agreement and all Lender-

Provided Interest Rate Hedges and repay in full the outstanding Obligations. This letter shall constitute Agent's statement of the amount required in order to pay such Obligations (other than contingent indemnification Obligations for which no claim has been made) in full as of the date hereof.

As of the date hereof, the outstanding Obligations (collectively, and as adjusted for any per diem required under the terms hereof, the "**Payoff Sum**"), are:

Borrowers acknowledge that the amounts set forth above as the Payoff Sum are its enforceable Obligations owed to Agent and the Lenders pursuant to the provisions of the Credit Agreement and the Other Documents.

If the Payoff Sum is not received in immediately available funds at the account listed below by 3:00 P.M. (Eastern time) on the date hereof, for each day (or portion thereof) thereafter until the Payoff Sum is so received, per diem interest and fees shall accrue and be payable in the amount of \$6,060.38 for each such day (or portion thereof). If the Payoff Sum is not received by 3:00 P.M. (Eastern time) on December 3, 2016, then this letter shall be of no further force or effect and the Borrowers must obtain a new letter detailing the Payoff Sum.

Subject to the terms hereof, upon Agent's and its counsel's receipt of the Payoff Sum as set forth above and a fully-executed copy of this letter (the date such items are received by Agent being the "**Payoff Date**"): (i) any and all commitments of the Lenders under the Credit Agreement or any Other Document shall immediately and automatically and without further action terminate, (ii) all of the Obligations, other than contingent indemnification Obligations for which no claim has been made, shall be paid and discharged in full and deemed satisfied, (iii) the Credit Agreement and the Other Documents shall immediately and automatically and without further action terminate, except for provisions thereof which expressly survive termination, (iv) all Lender-Provided Interest Rate Hedges shall immediately and automatically and without further action terminate, except for provisions thereof which expressly survive termination, and (v) all Liens granted to Agent or any Lender under the Credit Agreement or any Other Document shall immediately and automatically and without further action terminate and be released, and Borrowers and/or such other Person as Borrowers may designate (the "**Borrowers' Designee**") shall be authorized to (A) terminate and file the Uniform Commercial Code financing statements attached hereto as Exhibit A, (B) file the mortgage releases and intellectual property termination agreements delivered to Borrowers as of the date hereof attached hereto as Exhibit B and Exhibit C, respectively, and (C) file, record and/or deliver any other terminations, notices, releases, instruments and other documents necessary to evidence the release of the Agent's or any Lender's Liens and the satisfaction of the Obligations, and (v) the obligations of each Guarantor with respect to the Obligations shall immediately and automatically terminate without further action.

At any time after the Payoff Date, as reasonably requested by, and at the sole cost of, Borrowers, Agent shall deliver to Borrowers or the Borrowers' Designee with Borrowers' or Borrowers' Designee's written instructions provided to Agent, such other terminations, notices, releases, instruments, documents and/or evidence of the Lien releases provided herein as may be reasonably required to enable Borrowers or the Borrowers' Designee to terminate or release any Lien granted to Agent under the Credit Agreement or the Other Documents. Agent and the Lenders shall have no liability to any Borrower for the termination, release or assignment of any financing statement, mortgage or deed of trust or for the return of any possessory collateral, if Agent shall have complied with written instructions from Borrowers or the Borrowers' Designee.

If you wish to continue to use treasury management and other deposit account services with PNC after the payoff date, we reserve the right to revise (i) the fees relating thereto and (ii) the availability schedules for such services as permitted under Regulation CC. PNC acknowledges and agrees that, following payment of the Payoff Sum, account no. 8026291009 maintained by Tenon Industries with PNC and account no. 4116459137 maintained by Taupo Wood with PNC shall remain open but any liens in such accounts securing the Obligations shall have been released.

Each Borrower indemnifies Agent from and holds Agent harmless against, and agrees to pay to and reimburse Agent for, all loss, cost, damage, or expense (including, without limitation, bank charges) that Agent may suffer or incur as a result of the nonpayment, dishonor, or return for any reason of any check or other item of payment which Agent has credited against the Obligations on or prior to the date hereof. The amount of any such loss, cost, damage or expense indemnified hereupon shall be paid to Agent promptly by Borrowers upon Agent's demand therefor.


This letter may be executed by each party on a separate counterpart, each of which when so executed and delivered shall be an original, but all of which together shall constitute one agreement. Delivery of an executed counterpart of this letter agreement by facsimile or other similar method of electronic transmission shall have the same force and effect as the delivery of an original executed counterpart. Any party delivering an executed counterpart of this letter agreement by facsimile or other similar method of electronic transmission shall also deliver an original executed counterpart, but the failure to do so shall not affect the validity, enforceability or binding effect of this letter agreement. This letter shall be governed by the internal laws of the State of New York and construed in accordance with the terms of the Credit Agreement.

Upon the occurrence of the Payoff Date, each Borrower releases, discharges, and acquits Agent and each Lender, their respective officers, directors, shareholders, agents, employees, attorneys, subsidiaries, and affiliates, and their respective successors, assigns, heirs, and representatives (collectively, the "**Released Parties**"), on and with effect from the Payoff Date, from any and all further obligations to any Borrower or any Guarantor under or in connection with the Credit Agreement and the Other Documents and from any and all claims, rights, demands, injuries, debts, damages, liabilities, omissions, accounts, contracts, agreements, actions, and causes of action, whether at law or in equity, and whether based on contract, tort, or otherwise, known or unknown, suspected or unsuspected, of every kind and nature, which any Borrower or any Guarantor, or its successors, assigns, heirs, and representatives at any time had, now have, or hereafter can or may have against any of the respective Released Parties, in any way arising from or related to the Credit Agreement or Other Documents and the transactions thereunder; provided, however, that the Borrowers and Guarantors do not release, discharge or acquit Agent from its obligations specifically set forth in this letter agreement. It is the intention of each Borrower and each Guarantor that in executing this letter agreement that the same shall be effective as a bar to each and every claim, demand and cause of action hereinabove specified and in furtherance of this intention waives and relinquishes all rights and benefits under any provision of any applicable law which provides that a general release does not extend to claims which the creditor does not know or suspect to exist in his/its favor at the time of executing the release, which if known by him/it might have materially affected his/its settlement with the debtor.
