

**Action by Written Consent of the Board of Directors

WHEREAS, all of the Shareholders and Directors of the Corporation deem it to be in the best interest of the Corporation to allow the conversion, and, therefore, be it:


RESOLVED, That the conversion of the Corporation to a North Dakota manager-managed limited liability company is hereby approved;

RESOLVED, That the new entity shall now be known as IPC, LLC;


RESOLVED, That Martin Griffith, shall be appointed as the initial manager of IPC, LLC;
