**TERMINATION AND RELEASE OF  
TRADEMARK SECURITY AGREEMENT**

This TERMINATION AND RELEASE OF TRADEMARK SECURITY AGREEMENT (this "Termination"), dated as of July 1, 2021, is executed by AB PRIVATE CREDIT INVESTORS LLC, as administrative agent ("Administrative Agent"), in favor of EQUIP, LLC (f/k/a EQUIP, INC.), an Oregon limited liability company ("Grantor"). All capitalized terms used in this Termination and not otherwise defined herein, shall have the respective meanings given to such terms in the Security Agreement (defined below).

**RECITALS**

A. Pursuant to that certain Trademark Security Agreement, dated as of January 16, 2019 ("Security Agreement"), executed by Grantor in favor of Administrative Agent, Grantor granted to Administrative Agent a security interest in the Trademark Collateral (defined below).

B. The Security Agreement was recorded with the Trademark Division of the United States Patent and Trademark Office on March 15, 2019 at Reel 6592 and Frame 0971 to evidence the security interest granted under the Security Agreement.

C. Administrative Agent agrees to terminate and release its security interest in the Trademark Collateral specified below and to file this Termination with respect to such release of its security interest as herein provided.

**AGREEMENT**

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Administrative Agent hereby agrees as follows:

(a) Administrative Agent expressly terminates and releases all of Administrative Agent's right, title and interest in pursuant to the Security Agreement, to and under the following (collectively, the "Trademark Collateral"):

(i) Trademarks, whether now owned or at any time hereafter acquired by such Grantor or in which such Grantor now has or at any time in the future may acquire any right, title or interest, including the Trademarks listed on Schedule A attached hereto and to the extent not otherwise included, all Proceeds and products of any and all of the foregoing and all collateral security and guarantees given by any Person with respect to any of the foregoing.


(b) Administrative Agent represents and warrants that it has the full power and authority to execute this Termination.

(c) Administrative Agent authorizes and requests the Trademark Division of the United States Patent and Trademark Office to record this Termination.
