TRADEMARK RELEASE AND REASSIGNMENT

THIS TRADEMARK RELEASE AND REASSIGNMENT (this “Release”) is made as of June 30, 2021, by ANTARES CAPITAL LP, as administrative agent (in such capacity, together with its successors and permitted assigns, the “Agent”), in favor of Ascensus Specialties LLC, a Delaware limited liability company, and Ascensus Specialties Callery LLC (f/k/a Callery, LLC), a Delaware limited liability company (each, a “Grantor” and, collectively, the “Grantors”).

WITNESSETH:

WHEREAS, pursuant to the Guaranty and Security Agreement, dated as of September 24, 2019 among the Agent, the Grantors and certain other parties thereto (the “Guaranty and Security Agreement”), the Agent and the Grantors entered into that certain Trademark Security Agreement, dated as of September 24, 2019 (the “Trademark Security Agreement”), pursuant to which each Grantor granted to Agent, for the benefit of the Secured Parties, a Lien on and security interest in all of its right, title and interest in, to and under the Trademark Collateral, including the Trademarks set forth on Schedule 1 hereto, as collateral security for the prompt and complete payment and performance when due (whether at stated maturity, by acceleration or otherwise) of the Secured Obligations of such Grantor;

WHEREAS, the Trademark Security Agreement was recorded by the Trademark Division of the United States Patent and Trademark Office on September 24, 2019, at Reel 6752 Frame 0716;

WHEREAS, the Grantors have requested that Agent release, and the Agent has agreed to release, its security interest in the Trademark Collateral and reassign any and all rights in the same to each Grantor, as applicable.

NOW THEREFORE, for good and valuable consideration, receipt and sufficiency of which are hereby acknowledged, the Agent hereby agrees as follows:

1. Capitalized terms used but not defined herein shall have the meanings assigned to such terms in the Guaranty and Security Agreement or the Trademark Security Agreement, as applicable.

2. Agent hereby terminates the Trademark Security Agreement and irrevocably discharges, terminates and releases its Lien on and security interest in all of each Grantor’s right, title and interest in and to, as applicable, the Trademark Collateral, including but not limited to the following:

(i) all of its Trademarks, including, without limitation, those referred to on Schedule 1 hereto;

(ii) all renewals and extensions of the foregoing;

(iii) all goodwill of the business connected with the use of, and symbolized by, each such Trademark; and

(iv) all income, royalties, proceeds and Liabilities at any time due or payable or asserted under and with respect to any of the foregoing, including, without limitation, all rights to sue and recover at law or in equity for any past, present and future infringement, misappropriation, dilution, violation or other impairment thereof.


3. Agent hereby reassigns, grants and conveys to each Grantor, as applicable, without any representation, recourse or undertaking by Agent, any and all of Agent's right, title and interest in and to the Trademark Collateral.

4. This Release and the rights and obligations of the parties hereto shall be governed by, and construed and interpreted in accordance with, the laws of the State of New York.
