**TERMINATION AND RELEASE OF  
TRADEMARK SECURITY AGREEMENT**

This Termination and Release of Trademark Security Agreement (“Release”) is made as of July 2, 2021, by **CHINA MINSHENG BANKING CORP. LTD., HONG KONG BRANCH**, a joint stock limited company incorporated in the People’s Republic of China (the “Security Agent”) in favor of **SOURCE PHOTONICS, INC.**, a Delaware corporation with an address at 8521 Fallbrook Ave., Suite 200, West Hills, California 91304 (the “Grantor”).

W I T N E S S E T H:

WHEREAS, the Grantor entered into a certain Notice of Grant of Security Interest in Trademarks dated March 19, 2020 (the “Trademark Security Agreement”) with Security Agent, notice of which was recorded on March 19, 2020 at the United States Patent and Trademark Office at Reel 6896, Frame 0372.

Capitalized terms used but not otherwise defined herein have the meanings given to them in the Trademark Security Agreement.

WHEREAS, the Grantor granted the Security Agent, under the terms of the Trademark Security Agreement, a security interest (the “Security Interest”) in favor of the Security Agent, in and to all of such Grantor’s right, title and interest in the Trademark Collateral, including without limitation the trademarks listed in **Schedule A**, and all goodwill associated therewith or symbolized thereby.

WHEREAS, the Security Agent has agreed to terminate and release the entirety of its security interest in all such Trademark Collateral as herein provided.

NOW, THEREFORE, in consideration of the foregoing and intending to be legally bound, the Security Agent hereby releases, terminates and discharges any and all of its interest in the Trademark Collateral of the Grantor, including all goodwill associated therewith or symbolized thereby, and assigns, transfers and conveys to the Grantor the Security Interest in such Trademark Collateral.

The Security Agent hereby agrees, at the request and cost of the Grantor, to duly execute, acknowledge, procure and deliver any further documents and to do such other acts as may be necessary to effect the release of the Security Interest contemplated hereby.
