**RELEASE OF FIRST LIEN SECURITY INTEREST IN  
TRADEMARK COLLATERAL**

This **RELEASE OF FIRST LIEN SECURITY INTEREST IN TRADEMARK COLLATERAL**, dated as of July 2, 2021 (this “Release”), is made by ANTARES CAPITAL LP, as collateral agent (the “Collateral Agent”), in favor of SCOUTIT, INC., a Delaware corporation (the “Pledgor”). Unless otherwise defined herein, terms defined in the Security Agreement and used herein have the meaning given to them in the Security Agreement (as defined below), or if not defined therein, in the Credit Agreement (as defined below).

**WITNESSETH**

WHEREAS, MT Parent, LLC, a Delaware limited liability company, MT Parent, Inc., a Delaware corporation, Market Track, LLC, a Delaware limited liability company, the other parties party thereto from time to time, and the Collateral Agent are parties to that certain First Lien Credit Agreement, dated as of June 5, 2017 (as amended, restated, amended and restated, supplemented, extended, waived, renewed, replaced, refinanced or otherwise modified from time to time, the “Credit Agreement”);

WHEREAS, the Pledgor and the Collateral Agent are parties to that certain First Lien Security Agreement, dated as of June 5, 2017 (as amended, restated, amended and restated, supplemented, waived, renewed, replaced or otherwise modified from time to time, the “Security Agreement”);

WHEREAS, pursuant to the Security Agreement, the Pledgor executed the First Lien Trademark Security Agreement, dated as of September 19, 2017 (the “Trademark Security Agreement”) and recorded with the U.S. Patent and Trademark Office on September 20, 2017 at Reel/Frame No. 6157/0407, pursuant to which the Pledgor pledged and granted to the Collateral Agent for the benefit of the Secured Parties a Lien on and security interest in all of its right, title and interest in, to and under the Trademark Collateral (as defined in the Trademark Security Agreement).

WHEREAS, the Pledgor has requested that the Collateral Agent release its security interest in all of their right, title and interest in, to and under the Trademark Collateral.

NOW, THEREFORE, in consideration of the foregoing, the Collateral Agent hereby DISCHARGES, TERMINATES and RELEASES, without recourse, representation or warranty, its security interest in all right, title and interest in, to and under the Trademark Collateral, including the trademark registrations and applications set forth in Schedule I attached hereto and incorporated herein by reference, and agrees that all the security interest in the Trademark Collateral is hereby discharged, terminated and released. The undersigned hereby transfers and assigns to the Pledgor, without recourse, representation or warranty, any and all right, title and interest that the Collateral Agent may have obtained in, to and under the Trademark Collateral under the Security Agreement and the Trademark Security Agreement.
