## RELEASE OF SECURITY INTEREST IN TRADEMARKS

This RELEASE OF SECURITY INTEREST IN TRADEMARKS (this “**Release**”) is made as of July 1, 2021, by BANK OF AMERICA, N.A. (the “**Secured Party**”), in favor of Quality Distribution, LLC, Quality Carriers, Inc. and Boasso America Corporation (each, a “**Grantor**” and, together, the “**Grantors**”). Capitalized terms used but not defined herein have the meanings specified (including by reference) in the Trademark Security Agreements (as defined below), as applicable.

WHEREAS, the Grantors and the Secured Party are party to that certain Intellectual Property Security Agreement, dated as of August 18, 2015 (the “**2015 Trademark Security Agreement**”);

WHEREAS, Quality Distribution, LLC and the Secured Party are party to that certain Intellectual Property Security Agreement, dated as of August 15, 2016 (the “**2016 Trademark Security Agreement**”);

WHEREAS, Quality Carriers, Inc., Boasso America Corporation and the Secured Party are party to that certain Intellectual Property Security Agreement, dated as of August 28, 2019 (the “**2019 Trademark Security Agreement**” and, together with the 2015 Trademark Security Agreement and the 2016 Trademark Security Agreement, the “**Trademark Security Agreements**”);

WHEREAS, pursuant to the Trademark Security Agreements, the Grantors granted to the Secured Party a security interest in all of the Grantors’ right, title and interest in, to and under the ABL Collateral (as defined in the Trademark Security Agreements), including the Trademarks set forth on Schedule I hereto:

WHEREAS, the 2015 Trademark Security Agreement was recorded with the United States Patent and Trademark Office at Reel/Frame 5604/0432, the 2016 Trademark Security Agreement was recorded with the United States Patent and Trademark Office at Reel/Frame 5857/0297 and the 2019 Trademark Security Agreement was recorded with the United States Patent and Trademark Office at Reel/Frame 6734/0001; and

WHEREAS, the Grantors have requested that the Secured Party execute and deliver this Release to evidence the release of its security interest in the ABL Collateral for filing and recordation with the United States Patent and Trademark Office.


