TERMINATION AND RELEASE OF GRANT OF A SECURITY INTEREST --  
TRADEMARKS

This TERMINATION AND RELEASE OF GRANT OF A SECURITY INTEREST -- TRADEMARKS ("Termination and Release") dated as of June 9, 2021, is from UBS AG, Stamford Branch, as administrative agent and collateral agent (in such capacities, the "Administrative Agent") to SPIDAWEB LLC (the "Trademark Grantor"). Capitalized terms used in this Termination and Release and not otherwise defined herein have the meanings specified in the Security Agreement or the Trademark Security Agreement, as applicable.

WITNESSETH:

WHEREAS, pursuant to that certain Security Agreement, dated as of June 21, 2017 among the Trademark Grantor, the other grantors party thereto and the Administrative Agent (as amended, restated, supplemented or otherwise modified, the "Security Agreement"), the Trademark Grantor executed a Trademark Security Agreement, dated as of January 30, 2019 (as amended, restated, supplemented or otherwise modified, the "Trademark Security Agreement"), which was recorded in the United States Patent and Trademark Office at Reel 6557, Frame 0752 pursuant to which the Trademark Grantor granted a security interest to the Administrative Agent, for the benefit of the Secured Parties, in the certain trademarks and/or trademark applications listed on Schedule A hereto and made a part hereof (the "Trademark Collateral").

WHEREAS, the Administrative Agent now desires to terminate and release its security interest in the Trademark Collateral and reassign any and all rights, title, and interest in the same to the Trademark Grantor.


NOW, THEREFORE, for good and valuable consideration, receipt and sufficiency of which are hereby acknowledged:
