SELLER INTELLECTUAL PROPERTY ASSIGNMENT

This Seller Intellectual Property Assignment Agreement (the "Assignment") is made this 3rd day of May, 2021, by and between Southwind Building Products, LLC, a Delaware limited liability company ("Assignee") and Indian Summer Carpet Mills, Inc., a Georgia corporation ("Assignor").

WHEREAS, BAMR Holdings, Inc. a Florida corporation ("BAMR") and Assignor, Randall J. Hatch, Richard Abramowicz, and Bret Perkins, (collectively the "Seller") entered into an Asset Purchase Agreement (the "Purchase Agreement") dated as of March 27, 2021, whereby Seller agreed to sell, assign, transfer and convey to BAMR, and BAMR agreed to accept, Seller Intellectual Property (as defined in the Purchase Agreement), and

WHEREAS, BAMR has assigned all its rights and interests in the Purchase Agreement to Assignee, an affiliate under common control and ownership, and

WHEREAS Assignor desires to assign to Assignee all right, title and entire interest in and to Seller Intellectual Property, including but not limited to those Trademarks and domains as are set out in Schedule A attached hereto.

NOW, THEREFORE, for good and valuable consideration, the receipt of which is hereby acknowledged, the parties agree as follows:

1. Assignor hereby assigns to Assignee all right, title and interest in and to Seller Intellectual Property, including but not limited to the Trademarks set out on Schedule A, together with all rights and goodwill of the business symbolized by Seller Intellectual Property, all causes of action for damages by reason of past, present or future infringement thereof or misappropriation of any such rights, and all income, royalties or payments due as of the date hereof or hereafter.
2. Assignor agrees to execute all papers and perform such other proper acts as may be necessary or desirable to secure to Assignee or to its designee the rights herein assigned.
3. This Assignment shall be binding upon the parties and their respective successors and assigns.
4. If any provision hereof is held invalid or unenforceable by a court of competent jurisdiction, such invalidity shall not affect the validity or operation of any other provision and such invalid provision shall be deemed to be severed from the Assignment.
5. No waiver or modification of any of the terms of this Assignment shall be valid unless it is in writing. No waiver by either party of a breach hereof or a default hereunder shall be deemed a waiver by such party of any subsequent breach or default, whether of the same or similar nature.

6. This Assignment shall be governed by and construed in accordance with the laws of the State of Georgia.

7. This Assignment may be executed in facsimile and in one or more counterparts, each of which shall be deemed an original and all of which together shall constitute a single instrument.

8. The effective date of this Agreement shall be May 1, 2021 (the "Effective Date.")
