## Termination and Release of Intellectual Property Security Interest

This **Termination and Release of Intellectual Property Security Interest** (the "IP Release"), dated as of June 24, 2021 (the "Effective Date"), is made by PLAYSTUDIOS US, LLC (as successor by merger to PLAYSTUDIOS, INC., a Delaware corporation) (the "Grantor") and SILICON VALLEY BANK, a California corporation (the "Bank"). Grantor and Bank are sometimes referred herein as each a "Party" and, collectively, the "Parties."

**WHEREAS**, pursuant to the terms of (i) that certain Loan and Security Agreement, dated as of March 27, 2020, by and between Grantor and Bank (as amended, restated, modified or supplemented from time to time, the "Loan Agreement"), and (ii) that certain Intellectual Property Security Agreement, dated as of March 27, 2020, by and between Grantor and Bank (as amended, restated, modified or supplemented from time to time, the "IP Security Agreement," and collectively with the Loan Agreement, the "Security Agreements"), Grantor granted to Bank a security interest in all of Grantor's right, title and interest in and to the Intellectual Property Collateral (as defined in the IP Security Agreement), including, without limitation, the Copyrights, Patents, Trademarks and Mask Works listed on Exhibits A, B, C and D, attached hereto, together with all goodwill associated therewith or symbolized thereby (collectively, the "Released IP Collateral").

**WHEREAS**, the IP Security Agreement was recorded with the United States Patent and Trademark Office on March 30, 2020, at patent assignment Reel 052256, Frame 0066.

**WHEREAS**, the IP Security Agreement was recorded with the United States Patent and Trademark Office on March 30, 2020, at trademark assignment Reel 6902, Frame 0306.

**WHEREAS**, Grantor has satisfied in full the terms of the Security Agreements and requests a full release of the Released IP Collateral, and, effective as of the Effective Date, Bank wishes to fully terminate, discharge and release its lien and security interest in the Released IP Collateral.

**NOW, THEREFORE**, for good and valuable consideration, the receipt, adequacy and legal sufficiency of which are hereby acknowledged by the Parties, Bank hereby represents, warrants, covenants and agrees, for the benefit of Grantor, as follows:

1. Defined Terms. Unless otherwise defined herein, capitalized terms defined in the Loan Agreement or IP Security Agreement, and used herein, have the meaning given to them in the Loan Agreement or IP Security Agreement, as applicable.
2. Release of Security Interest. The Bank agrees to fully terminate, release, cancel and discharge, and hereby does fully, unconditionally and irrevocably terminate, release, cancel and discharge, its lien and security interest in all of each Grantor's present and future right, title and interest in and to the Released IP Collateral, including, without limitation:
  - a. Any and all copyright rights, copyright applications, copyright registrations and like protections in each work of authorship and derivative work thereof, whether published or unpublished and whether or not the same also constitutes a trade secret, now or hereafter existing, created, acquired or held, including without



limitation those set forth on Exhibit A attached hereto (collectively, the "Copyrights");

- b. Any and all trade secrets, and any and all intellectual property rights in computer software and computer software products now or hereafter existing, created, acquired or held;
- c. Any and all design rights that may be available to Grantor now or hereafter existing, created, acquired or held;
- d. All patents, patent applications and like protections including, without limitation, improvements, divisions, continuations, renewals, reissues, extensions and continuations-in-part of the same, including without limitation the patents and patent applications set forth on Exhibit B attached hereto (collectively, the "Patents");
- e. Any trademark and servicemark rights, whether registered or not, applications to register and registrations of the same and like protections, and the entire goodwill of the business of Grantor connected with and symbolized by such trademarks, including without limitation those set forth on Exhibit C attached hereto (collectively, the "Trademarks");
- f. All mask works or similar rights available for the protection of semiconductor chips, now owned or hereafter acquired, including without limitation those set forth on Exhibit D attached hereto (collectively, the "Mask Works");
- g. Any and all claims for damages by way of past, present and future infringements of any of the rights included above, with the right, but not the obligation, to sue for and collect such damages for said use or infringement of the intellectual property rights identified above;
- h. All licenses or other rights to use any of the Copyrights, Patents, Trademarks, or Mask Works and all license fees and royalties arising from such use to the extent permitted by such license or rights;
- i. All amendments, extensions, renewals and extensions of any of the Copyrights, Trademarks, Patents, or Mask Works; and
- j. All proceeds and products of the foregoing, including without limitation all payments under insurance or any indemnity or warranty payable in respect of any of the foregoing.

3. Recordation and Further Assurances. Bank hereby authorizes the applicable Grantor to (i) record this IP Release with the USPTO, (ii) file UCC financing statement amendments with the applicable filing office in order to memorialize the release of the security interest of the Bank in the Released IP Collateral, and/or (iii) otherwise record or file this IP Release in the applicable foreign or domestic governmental office or agency. Bank hereby further agrees to duly execute, acknowledge, procure and deliver any further documents and to do such

other acts, in each case at such Grantor's expense, as may be reasonably necessary to effect the release of the security interest in the Released IP Collateral contemplated hereby.

4. Counterparts. This IP Release may be executed in any number of counterparts and by the different Parties hereto in separate counterparts, each of which when so executed shall be deemed to be an original, and all of which taken together shall constitute one and the same agreement. Delivery of an executed counterpart of a signature page to this IP Release electronically or by telecopy shall be as effective as delivery of a manually executed counterpart of this IP Release.

5. Successors and Assigns. This IP Release will be binding on and shall inure to the benefit of the Parties hereto and their respective permitted successors and assigns.

6. Severability. Each provision of this IP Release will be interpreted in such a manner as to be effective and valid under applicable law, but if any term or other provision of this IP Release is held to be invalid, illegal or unenforceable under applicable law, all other provisions of this IP Release shall remain in full force and effect.

7. Governing Law. This IP Release and any claim, controversy, dispute or cause of action (whether in contract or tort or otherwise) based upon, arising out of or relating to this IP Release and the transactions contemplated hereby and thereby shall be governed by, and construed in accordance with, the laws of the United States and the State of New York, without giving effect to any choice or conflict of law provision or rule (whether of the State of New York or any other jurisdiction).
