**ASSIGNMENT OF NOTICE OF GRANT OF SECURITY INTEREST IN
TRADEMARKS**

This ASSIGNMENT OF NOTICE OF GRANT OF SECURITY INTEREST IN TRADEMARKS (this “Assignment”), dated as of July 2, 2021, is by FÉDÉRATION DES CAISSES DESJARDINS DU QUÉBEC, a financial services cooperative organized under the laws of Canada, in its capacity as resigning Security Agent (as defined in the US Security Agreement described below, and in such capacity, the “Existing Agent”) and NATIONAL BANK OF CANADA, a bank organized under the laws of Canada, in its capacity as successor Security Agent (in such capacity, the “Successor Agent”).

RECITALS:

WHEREAS, AGROPUR INC., a Wisconsin corporation, and AGROPUR MSI, LLC, a Wisconsin limited liability company, as “Grantors” and certain other grantors party thereto, and Existing Agent are parties to a US Security Agreement dated as of May 29, 2020 (as the same have been and may hereafter be amended, restated, supplemented or otherwise modified from time to time, including, without limitation, as amended and restated pursuant to the Amended and Restated U.S. Security Agreement, dated as of June 16, 2021, which agreement may be further amended, restated, supplemented or otherwise modified from time to time, collectively, the “Agreement”) pursuant to which each Grantor granted a security interest in and to and lien upon the intellectual property identified in Schedule 1, which security interest was recorded with the United States Patent and Trademark Office at Reel/Frame No. 7012/0290; and

WHEREAS, pursuant to that certain Fourth A&R Credit Agreement, dated as of June 16, 2021, by and among the Existing Agent, Successor Agent, the Grantors and certain other grantors party thereto, Existing Agent has resigned as Security Agent under the Agreement, and the Successor Agent has been appointed as successor Security Agent thereunder.


