TRADEMARK ASSIGNMENT AGREEMENT

This TRADEMARK ASSIGNMENT AGREEMENT (this “**Agreement**”), effective as of **May 31, 2021**, is made by Want Holdings Inc., a corporation organized under the laws of Canada with an address of 8480 Jeanne Mance, Montreal, Québec, Canada H2P2S3 (the “**Company**”), in favor of Quartz Nature Inc., a corporation organized under the laws of Canada with an address of 101 Maguire Street, Montreal, Québec, H2T 0A8 Canada (“**Assignee**”).

WHEREAS, the parties agreed that Company would assign, transfer, convey and deliver to the Assignee certain intellectual property of the Company; and

WHEREAS, the parties hereby execute and deliver this Agreement for recording with the Trademark Office or equivalent entities or agencies in any applicable jurisdictions;

NOW, THEREFORE, the parties agree as follows:

1. **Assignment.** For CAN\$5 and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Company hereby irrevocably assigns, transfers, conveys and delivers to the Assignee all of the Company’s right, title and interest in and to the following (the “**Marks**”):

(a) the trademark registrations and applications set forth in **Exhibit A** hereto, together with the common law rights thereto and the goodwill of the business symbolized thereby, including that portion of the business to which the Marks pertain;

(b) all rights of any kind whatsoever of the Company accruing under any of the foregoing provided by applicable law of any jurisdiction, by international treaties and conventions and otherwise throughout the world, including, without limitation, the right to apply for and receive registrations of the Marks throughout the world;

(c) any and all royalties, fees, income, payments and other proceeds now or hereafter due or payable with respect to any and all of the foregoing; and

(d) any and all claims and causes of action with respect to any of the foregoing, whether accruing before, on or after the date hereof, including all rights to and claims for damages, restitution and injunctive and other legal and equitable relief for past, present and future infringement, misappropriation, violation, misuse, breach or default, with the right but no obligation to sue for such legal and equitable relief and to collect, or otherwise recover, any such damages.

2. **Recordation and Further Actions.** The Company hereby authorizes the Trademark Office and the officials of equivalent entities or agencies in any applicable jurisdictions to record and register this Agreement upon request by the Assignee.


3. **Counterparts.** This Agreement may be executed in counterparts, each of which shall be deemed an original, but all of which together shall be deemed to be one and the same agreement. A signed copy of this Agreement delivered by facsimile, e-mail or other means of electronic

transmission shall be deemed to have the same legal effect as delivery of an original signed copy of this Agreement.

4. Successors and Assigns. This Agreement shall be binding upon and shall inure to the benefit of the parties hereto and their respective successors and assigns.


