**TERMINATION AND RELEASE
OF SECURITY INTEREST IN TRADEMARKS**

This **TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS** (“Release”) is executed as of July 2, 2021 (“Effective Date”), by NORTHCREEK MEZZANINE FUND III, L.P., as secured party (the “Secured Party”) under the Security Agreement and IP Security Agreement (as defined below), in favor of ZRG PARTNERS, LLC, a Delaware limited liability company (“Borrower”), ZRG PARTNERS HOLDINGS CORP., a Delaware corporation (“Holdco”), ZRG TOFT GROUP, LLC, a Delaware limited liability company (“ZRG Group”), and ZRG INTERIM SOLUTIONS, LLC, a Delaware limited liability company (“ZRG Solutions”) (Borrower, Holdco, ZRG Group and ZRG Solutions are collectively the “Released Parties”).

WHEREAS, reference is made to that certain Note Purchase Agreement dated as of dated as of October 14, 2020 (as amended, supplemented or otherwise modified from time to time, the “Note Purchase Agreement”), between Borrower and Secured Party;

WHEREAS, in connection with the Note Purchase Agreement, the Released Parties executed and delivered that certain Security Agreement dated as of October 14, 2020 (as amended, supplemented or otherwise modified from time to time, the “Security Agreement”);

WHEREAS, pursuant to the Note Purchase Agreement and the Security Agreement, the Released Parties and the Secured Party executed that certain Intellectual Property Security Agreement dated as of October 14, 2020 (as amended, supplemented or otherwise modified from time to time, the “IP Security Agreement”), pursuant to which the Released Parties granted to the Secured Party a continuing security interest in all of the Collateral (as such term is defined in the IP Security Agreement) to secure the payment of all Obligations (as such term is defined in the Note Purchase Agreement) (such continuing security interest in all of the Collateral, the “Security Interest”);

WHEREAS, the Released Party has satisfied in full the terms of the Security Agreement and the IP Security Agreement and requests a release of the Security Interest; and

WHEREAS, the Secured Party, on behalf of itself and each of the Lender, now agrees to terminate and grant a release of the Security Interest in the Trademarks (as such term is defined in the IP Security Agreement, including, without limitation, the Trademarks identified on Schedule A attached hereto as provided in this Release.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Secured Party hereby covenants and agrees as follows:

Unless otherwise defined herein or the context otherwise requires, terms used in this Release, including its preamble and recitals, have the meanings provided in the Note Purchase Agreement.

The Secured Party, hereby (a) terminates the IP Security Agreement, (b) terminates, releases, relinquishes and discharges, in its entirety, the Security Interest in each of the Trademarks identified on Schedule A attached hereto, and (c) hereby assigns and transfers to the Released Party, without recourse or representation or warranty, express or implied, of any kind, all of its right, title and interest of any nature whatsoever in and to the Trademarks (as such term is defined in the IP Security Agreement, including, without limitation, the Trademarks identified on Schedule A attached hereto, together, without limitation, with all associated common law rights and all goodwill of the business symbolized thereby, and all rights to sue and recover at law or in equity for any past, present and future infringement,

misappropriation, dilution, violation or other impairment thereof, in each case, effective as of the date hereof.

The Secured Party authorizes the USPTO and any other applicable governmental authority to record this Release and understands and agrees that this Release may be recorded by or for the Released Party with the USPTO or any similar office or agency within or outside the United States.


