**TERMINATION AND RELEASE OF SECURITY INTEREST IN  
INTELLECTUAL PROPERTY**

**THIS TERMINATION AND RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY**, dated as of June 28, 2021, is made by **THE HUNTINGTON NATIONAL BANK**, as successor to FirstMerit Bank, N.A., in its capacity as Lender and Secured Party (as defined below) (together with its successors and assigns in such capacity, "Lender"), under that certain Second Amendment to Trademark Security Agreement, dated as of April 16, 2018, by **CLASSIC ACCESSORIES, LLC**, a Delaware limited liability company ("Grantor") in favor of Lender (as amended, restated, supplemented or modified and in effect from time to time, the "IP Security Agreement"). Capitalized terms used but not defined herein shall have the meanings set forth in the IP Security Agreement.

**WHEREAS**, pursuant to the IP Security Agreement, Grantor granted a security interest to Lender in certain intellectual property collateral including the intellectual property set forth on Exhibit A attached thereto (the "IP Collateral"); and

**WHEREAS**, Lender has agreed to terminate and release its security interest in all of such IP Collateral so long as all of the conditions precedent set forth in that certain Commercial Loan Payoff Letter dated as of the date hereof have been fulfilled.

**NOW, THEREFORE**, for good and valuable consideration, the receipt of which is hereby acknowledged, Lender does hereby, in each case, without recourse, representation or warranty of any kind whatsoever, (a) terminate the liens and security interest created under the IP Security Agreement in the IP Collateral, (b) release its security interest in the IP Collateral, and (c) discharge any and all rights, title and interest it has in and the security interest granted to Lender in the IP Collateral.
