RELEASE OF SECURITY INTEREST IN TRADEMARKS

THIS RELEASE OF SECURITY INTEREST IN TRADEMARKS (this "Release") is made as of July 7, 2021 ("Effective Date") by Wells Fargo Bank, National Association, a national banking association, as Collateral Agent (the "Collateral Agent"), in favor of Beverages & More, Inc., a Delaware corporation ("Grantor").

WHEREAS, pursuant to the terms and conditions of that certain Trademark Security Agreement by and between Grantor and the Collateral Agent dated January 26, 2016 (the "Trademark Security Agreement"), Grantor granted to the Collateral Agent a continuing security interest in and to all of Grantor's right, title and interest in, to and under the trademark registrations and applications owned by Grantor, including those set forth on Exhibit A hereto (the "Trademarks"), in each case, together with the goodwill associated therewith;

WHEREAS, the Trademark Security Agreement was recorded with the United States Patent and Trademark Office on January 27, 2016, at Reel 005716 Frame 0559; and

WHEREAS, Grantor has paid all of its outstanding indebtedness to the Collateral Agent.


NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Collateral Agent hereby terminates the Trademark Security Agreement, and hereby terminates, cancels and releases any and all security interests it has against the Trademarks. This release is made by the Collateral Agent without recourse, representation or warranty, express or implied, at law or in equity, and without recourse to the Collateral Agent, in any event or in any contingency.

The Collateral Agent shall take all further actions, and provide to Grantor, its successors, assigns or other legal representatives, all such cooperation and assistance (including, without limitation, the execution and delivery of any and all documents or other instruments), requested by Grantor to more fully and effectively effectuate the purposes of this Release.

The Collateral Agent authorizes and requests the Director of Patents and Trademarks of the United States of America or her delegate to record this Release against the Trademarks. [THE
