**TERMINATION AND RELEASE OF
SECURITY INTEREST IN TRADEMARKS**

This Termination and Release of Security Interest in Trademarks (“Release”) is made as of June 30, 2021, by **BARCLAYS BANK PLC** (“Common Collateral Agent”) in favor of Thrifty Rent-A-Car System, LLC, an Oklahoma limited liability company (the “Grantor”). Capitalized terms used but not otherwise defined herein have the meanings given to them in the Trademark Security Agreement, whether defined therein or by reference to another agreement.

W I T N E S S E T H:

WHEREAS, the Grantor, the Common Collateral Agent and certain other parties entered into that certain Amended and Restated Guarantee and Collateral Agreement, dated as of November 2, 2017 (as it may have been further amended, amended and restated, waived, supplemented or otherwise modified from time to time, the “Guarantee and Collateral Agreement”), pursuant to which the Grantor executed and delivered that certain Trademark Security Agreement dated May 19, 2020 (the “Trademark Security Agreement”) in favor of the Common Collateral Agent, which was recorded on May 19, 2020 at the United States Patent and Trademark Office (“USPTO”) at Reel/Frame 6942/0478;

WHEREAS, pursuant to the Guarantee and Collateral Agreement and the Trademark Security Agreement, the Grantor granted to the Common Collateral Agent, for the benefit of the Secured Parties, a security interest (the “Security Interest”) in all of the Trademark Collateral of such Grantor, including without limitation the Trademarks listed in **Schedule A** (the “Trademark Collateral”); and

WHEREAS, the Common Collateral Agent has agreed to terminate and release the Security Interest in the Trademark Collateral.

NOW, THEREFORE, in consideration of the foregoing and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Common Collateral Agent, hereby (a) terminates and cancels the Trademark Security Agreement, (b) releases, discharges, terminates and cancels the Security Interest in the Trademark Collateral (including without limitation the Trademarks listed in **Schedule A**), and (c) re-assigns to the Grantor any right, title or interest it may have in the Trademark Collateral, in each case without recourse to the Common Collateral Agent and without representation or warranty of any kind.


