TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS

This Termination and Release of Security Interest in Trademarks ("<u>Release</u>") is made as of June 30, 2021, by **BARCLAYS BANK PLC** ("<u>Common Collateral Agent</u>") in favor of Hertz System, Inc., a Delaware corporation, and Dollar Rent A Car, Inc., an Oklahoma corporation (each a "<u>Grantor</u>", and together the "<u>Grantors</u>"). WHEREAS, the Common Collateral Agent has agreed to terminate and release the Security Interest in the Trademark Collateral.
