**TERMINATION AND RELEASE OF  
SECURITY INTEREST IN TRADEMARKS**

This Termination and Release of Security Interest in Trademarks (“Release”) is made as of June 30, 2021, by **BARCLAYS BANK PLC** (“Common Collateral Agent”) in favor of Hertz System, Inc., a Delaware corporation, Dollar Rent A Car, Inc., an Oklahoma corporation, and Thrifty Rent-A-Car System, LLC, an Oklahoma limited liability company (each a “Grantor”, and collectively, the “Grantors”). Capitalized terms used but not otherwise defined herein have the meanings given to them in the Trademark Security Agreement, whether defined therein or by reference to another agreement.

W I T N E S S E T H:

WHEREAS, the Grantors, the Common Collateral Agent and certain other parties entered into that certain Amended and Restated Guarantee and Collateral Agreement, dated as of November 2, 2017 (as it may have been further amended, amended and restated, waived, supplemented or otherwise modified from time to time, the “Guarantee and Collateral Agreement”), pursuant to which the Grantors executed and delivered that certain Trademark Security Agreement, dated May 6, 2020 (the “Trademark Security Agreement”) in favor of the Common Collateral Agent, which was recorded on May 6, 2020 in the United States Patent and Trademark Office (“USPTO”) at Reel/Frame 6931/0405 (Hertz System, Inc.), Reel/Frame 6931/0418 (with respect to Dollar Rent A Car, Inc.) and Reel/Frame 6942/0798 (with respect to Thrifty Rent-A-Car System, LLC);

WHEREAS, pursuant to the Guarantee and Collateral Agreement and the Trademark Security Agreement, the each Grantor granted to the Common Collateral Agent, for the benefit of the Secured Parties, a security interest (the “Security Interest”) in all of the Trademark Collateral of such Grantor, including without limitation the Trademarks of such Grantor listed in **Schedule A**; and

WHEREAS, the Common Collateral Agent has agreed to terminate and release the Security Interest in the Trademark Collateral.

NOW, THEREFORE, in consideration of the foregoing and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Common Collateral Agent, hereby (a) terminates and cancels the Trademark Security Agreement, (b) releases, discharges, terminates and cancels the Security Interest in the Trademark Collateral (including without limitation the Trademarks listed in **Schedule A**), and (c) re-assigns to each Grantor any right, title or interest it may have in the Trademark Collateral of such Grantor, in each case without recourse to the Common Collateral Agent and without representation or warranty of any kind.

Each Grantor, or any successor to such Grantor (including any person or entity hereafter having any right, title or interest in or to the Trademark Collateral of such Grantor), is hereby authorized to record this Release in the USPTO.
