NUNC PRO TUNC TRADEMARK ASSIGNMENT

NOW, THEREFORE, for the sum of at least ten dollars (\$10.00) and other good and valuable consideration paid by Assignee to Assignor, the full receipt and sufficiency of which are hereby acknowledged and intending to be legally bound hereby, **Assignor hereby assigns, transfers, and conveys, nunc pro tunc, to Assignee, all rights, title, and interest as Assignor may possess in and to the Trademarks worldwide, together with the goodwill associated with and symbolized by said Trademarks.**

This Assignment shall be binding upon and inure to the benefit of the Assignor and Assignee, and their respective principals, affiliates, subsidiaries, successors, licensees, and assigns.


