**RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY**

This **RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY**, dated as of July 9, 2021 (the "Release"), is made by ANTARES CAPITAL LP, as Collateral Agent (the "Collateral Agent"), in favor of TECHNIMARK LLC, a North Carolina limited liability company (the "Grantor"). All capitalized terms used but not otherwise defined herein have the meanings assigned to them in the Security Agreement (as defined below).

**WITNESSETH**

WHEREAS, the Grantor and the Collateral Agent entered into that certain Security Agreement, dated as of August 8, 2018 (the "Security Agreement");

WHEREAS, pursuant to the Security Agreement, the Grantor executed the (i) Trademark Security Agreement, dated as of August 8, 2018 (the "Trademark Security Agreement"), and recorded with the U.S. Patent and Trademark Office ("USPTO") on August 8, 2018 at Reel/Frame No. 6407/0473 and the (ii) Patent Security Agreement, dated as of August 8, 2018 (the "Patent Security Agreement"), and recorded with the USPTO on August 8, 2018 at Reel/Frame No. 46747/0021;

WHEREAS, pursuant to the Security Agreement and the Trademark Security Agreement the Grantor mortgaged, pledged and hypothecated to the Collateral Agent for the benefit of the Secured Parties, and granted to the Collateral Agent for the benefit of the Secured Parties a Lien on and security interest in, all of its right, title and interest in, to and under the Trademark Collateral (as defined in the Trademark Security Agreement);

WHEREAS, pursuant to the Security Agreement and the Patent Security Agreement, the Grantor mortgaged, pledged and hypothecated to the Collateral Agent for the benefit of the Secured Parties, and granted to the Collateral Agent for the benefit of the Secured Parties a Lien on and security interest in, all of its right, title and interest in, to and under the Patent Collateral (as defined in the Patent Security Agreement); and

WHEREAS, the Grantor has requested that the Collateral Agent release its security interest in all right, title and interest in, to and under all of the Trademark Collateral and Patent Collateral.


NOW, THEREFORE, in consideration of the foregoing, the Collateral Agent hereby DISCHARGES, TERMINATES and RELEASES, without recourse, representation or warranty, its security interest in all right, title and interest in, to and under all of the Trademark Collateral and Patent Collateral, including the trademark registrations, issued patents and patent applications set forth in Schedule I attached hereto and incorporated herein by reference, and agrees that all the security interest in the Trademark Collateral and Patent Collateral is hereby discharged, terminated and released. The undersigned hereby transfers and assigns to the Grantor, without recourse, representation or warranty, any and all right, title and interest that the Collateral Agent may have obtained in, to and under the Trademark Collateral and Patent Collateral under the Security Agreement, the Trademark Security Agreement, and the Patent Security Agreement.

The Grantor, or any successor to the Grantor (including any person or entity hereafter having any right, title or interest in or to the Patent Collateral or Trademark Collateral), is hereby authorized to record this Release in the USPTO.
