## TERMINATION AND RELEASE OF TRADEMARK SECURITY INTEREST

This **TERMINATION AND RELEASE OF TRADEMARK SECURITY INTEREST**, dated as of July 8, 2021 (“Release”), is made by BMO HARRIS BANK N.A., as administrative agent for itself and the other Lender Parties (“Second Lien Agent”) in favor of The Best Label Company, LLC, a Delaware limited liability company (“Best Label”) and Paragon Labels, LLC, a Delaware limited liability company (“Paragon”) and together with Best Label, each a “Grantor” and together, the “Grantors”).

**WHEREAS**, pursuant to that certain Second Lien Pledge and Security Agreement, dated as of May 26, 2017, made by and among the Grantors and each of the other entities listed as party thereto in favor of the Second Lien Agent a security interest (the “Security Interest”) in certain collateral, including the patent collateral described herein.

**WHEREAS**, as a condition of the Second Lien Pledge and Security Agreement, Best Label executed that certain Trademark Security Agreement, dated as of November 15, 2018 (the “Best Label IP Security Agreement”), and Paragon executed that certain Trademark Security Agreement, dated as of September 13, 2018 (the “Paragon IP Security Agreement” and, together with the Best Label IP Security Agreement, the “IP Security Agreement”), and each granted to Second Lien Agent a security interest in all right, title and interest of such Grantor in and to the applicable Trademarks listed on Schedule A attached hereto.

**WHEREAS**, the Best Label IP Security Agreement was recorded at the United States Patent and Trademark Office (“USPTO”) on November 15, 2018 at Reel 006482 Frame 0369 and the Paragon IP Security Agreement was recorded at the USPTO on September 14, 2018 at Reel 006439 Frame 0088.

**WHEREAS**, Grantors have satisfied the terms of the IP Security Agreements and request a specific release of the security interests granted and recorded against its intellectual property.

**NOW THEREFORE**, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Second Lien Agent hereby agrees as follows:

**SECTION 1. Defined Terms.** All capitalized terms used herein but not otherwise defined herein have the meanings given to them in the IP Security Agreements.

**SECTION 2. Termination and Release.** Second Lien Agent, without representation, warranty, or recourse, hereby:

(a) terminates the IP Security Agreements and terminates, cancels, discharges, and releases all of its security interests in and to all right, title and interest of Grantors in and to all intellectual property (including, but not limited to, all Trademark Collateral under the IP Security Agreements), whether granted pursuant to the IP Security Agreements or otherwise (and including, but not limited to, the Trademarks listed on Schedule A attached hereto);

(b) assigns and transfers to Grantors all of their respective right, title and interest in and to all intellectual property, whether granted pursuant to the applicable IP Security Agreement or otherwise (including, but not limited to the Trademarks listed on Schedule A attached hereto), together with the goodwill of the business symbolized thereby;

(c) authorizes Grantors or any of their authorized representatives to file this Release with the USPTO or any similar office or agency within or outside the United States at Grantors’ expense; and

(d) agrees to execute, acknowledge, procure, and deliver any further documents and to do such other acts as may be reasonably requested by Grantors, at Grantors' expense, to fully effectuate the purposes of this Release.


**SECTION 3. Choice of Law.** This Release shall be governed by and construed in accordance with the laws of the State of New York.
