**TERMINATION AND RELEASE OF  
TRADEMARK SECURITY AGREEMENT**

This **TERMINATION AND RELEASE OF TRADEMARK SECURITY AGREEMENT** (this "*Termination and Release*") is granted as of July 9, 2021 by **SILICON VALLEY BANK**, as Administrative Agent, a California corporation, with a loan production office located at 275 Grove Street, Newton, Massachusetts 02466 ("**Bank**"), in favor of **REAL TIME, INC.**, a Delaware corporation (the "**Grantor**").

**WHEREAS**, the Grantor executed and delivered a Trademark Security Agreement, dated as of May 15, 2017 (the "**Agreement**"), granting to the Bank a security interest in all of its right, title and interest, whether presently existing or hereafter acquired, in, to and under the Trademarks (as defined in the Agreement), notice of which was recorded with the United States Patent and Trademark Office ("**USPTO**") on May 5, 2017 at Reel 6058, Frame 6058.

**WHEREAS**, Grantor has requested that Bank hereby terminate, release and discharge fully its security interests in and liens on all right, title and interest of Grantor in, to and under all of the Trademarks as herein provided; and

**WHEREAS**, Grantor has requested that the Bank provide a document suitable for recording with the USPTO to evidence the release of the Bank's security interests in and liens on the Trademarks as herein provided.


**NOW, THEREFORE**, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Bank hereby:

2. authorizes and requests that this Termination and Release be recorded with the USPTO.
