## **TERMINATION AND RELEASE OF TRADEMARK SECURITY AGREEMENT**

This **TERMINATION AND RELEASE OF TRADEMARK SECURITY AGREEMENT**, dated as of August 31, 2020 (“Release”), is made by WESTERN ALLIANCE BANK, an Arizona corporation, (the “Bank”) in favor of WESTCOAST GATE & ENTRY SYSTEMS, LLC, a Delaware limited liability company (“Grantor”), pursuant to that certain Security Agreement dated December 21, 2018 (as amended, restated, supplemented, modified, extended, renewed or replaced from time to time, the “Security Agreement”), among Grantor, the Bank and others party thereto.

**WHEREAS**, pursuant to that certain Security Agreement, Grantor executed and delivered to the Bank the Trademark Security Agreement, recorded at the United States Patent and Trademark Office (“USPTO”) on December 21, 2018 at Reel 6508 Frame 0085 (“Notice”), under which Grantor granted to the Bank a continuing security interest in Grantor’s right, title, and interest in and to the Trademark listed on Schedule I attached hereto (the “Trademark”).

**NOW THEREFORE**, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Bank and Grantor agree as follows:

**SECTION 1. Defined Terms.** All capitalized terms used herein but not otherwise defined herein have the meanings given to them in the Security Agreement.

**SECTION 2. Termination and Release.** The Bank, without representation, warranty, or recourse, hereby:


(a) terminates, cancels, discharges, and releases the continuing security interest in, Grantor’s right, title, and interest in and to all of its Trademarks and Trademark Intellectual Property Licenses referred to on Schedule I, the Trademark and use thereof, together with all proceeds and products thereof and the goodwill of the businesses symbolized by the Trademark, granted pursuant to the Security Agreement or Notice; and

(b) authorizes the recordation of this Release with the USPTO at Grantor’s expense.
