TRADEMARK ASSIGNMENT

This Trademark Assignment ("Agreement") is made effective as of June 7, 2021 by and between Cynthia May Niemczyk-Hodges and Wayne Bradley Hodges (hereinafter, the "Assignors"), on the one hand, and Luxury Escapes Travel Pty Ltd., an Australian corporation (hereinafter "Assignee"), on the other. For purposes of this Agreement, Assignor and Assignee may be referred to individually as a "Party," and collectively as the "Parties."

WHEREAS, Assignors warrant and represent that they are the joint owners of all right, title and interest in and to the trademark CAREFREE LUXURY ESCAPES, together with United States Trademark Registration Nos. 4428078 and 4330108 therefor, (hereinafter, collectively the "Trademark"), used in connection with the services offered by Assignors and their predecessors-in-interest (e.g., World Incentives, Inc., a Massachusetts corporation) under the Trademark including without limitation the services described in such registrations (hereinafter, collectively the "Services"), together with the goodwill of the business symbolized by the Trademark.

NOW THEREFORE, in consideration of the mutual covenants herein and in the Trademark Purchase and Assignment Agreement concurrently executed by the Parties, and for other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Assignors hereby assign and transfer to Assignee all right, title and interest in and to the Trademark, together with United States Trademark Registration Nos. 4428078 and 4330108 therefor, and the good will of the business symbolized thereby, or portion thereof, to which the mark pertains, and together with all claims for damages by reason of past infringement thereof or act of unfair competition relating thereto, with the right to sue for damages, and collect the same for Assignee's own use and benefit, and for the use and benefit of its successors, assigns, and legal representatives.



All of the recitals referred to in this Agreement are made a part hereof and incorporated in this Agreement by this reference.




