RELEASE OF SECURITY INTEREST

This Release of Security Interest is made as of July 12, 2021, by COMERICA BANK, a Texas banking association ("Bank") in favor of CVSTOM CO., a Delaware corporation ("CVSTOM"), and KJELD AAMODT, D.D.S., M.S., P.C., a California professional corporation ("Dental Group", and together with CVSTOM, are each a "Grantor" and collectively, the "Grantors"; each reference to "Grantor" or "Grantors" in this Agreement shall mean and refer to each Grantor, individually, and/or to all the Grantors, collectively and in the aggregate, as determined by Bank as the context may require), with its principal place of business located at 999 Sutter Street, Suite 102, San Francisco, CA 94109.

Recital

WHEREAS each Grantor granted to Bank a security interest in the trademark described on Exhibit A attached hereto (the "Intellectual Property Collateral") under an Intellectual Property Security Agreement dated as of September 10, 2020, by and between Grantors and Bank, as amended from time to time (the "Security Agreement") and recorded with the US Patent and Trademark Office as set forth on Exhibit A.

WHEREAS each Grantor has no outstanding obligations to Bank under the terms of the Security Agreement, Bank agrees to release its security interest in the Intellectual Property Collateral.

Agreement


