Third: The name of the surviving corporation is Amazon Technologies, Inc.

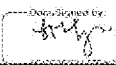
Fourth: The Agreement of Merger is on file at 410 Terry Avenue N, Seattle, WA 98109, the place of business of the surviving corporation.
