Confirmation of transfer of rights

1. Preamble

Mr. Heinrich Kipp (transferor entity), owner of the sole proprietorship **Kipp Verpachtungen e.K.**, Heubergstraße 2, 72172 Sulz am Neckar, DE, registered in the commercial register of Stuttgart under HRA 480696, and **ICG GmbH & Co. KG**, Heubergstraße 2, 72172 Sulz am Neckar, DE (transferee entity), registered in the commercial register of Stuttgart under HRA 736727, have concluded a spin-off and transfer agreement on June 17, 2020. According to the agreement, the assets of the sole proprietorship are transferred to ICG GmbH & Co. KG by means of spin-off by inclusion, becoming effective at the time the spin-off is entered in the commercial register. The agreement provides in § 3 in particular for the following regulation:

§3

Transfer of assets of "Kipp Verpachtungen e. K.";

- (1) Mr. Heinrich Kipp transfers to ICG GmbH & Co. KG all assets (aktiva) attributable to the sole proprietorship "Kipp Verpachtungen e. K.", regardless of whether or not they are or can be included in the balance sheet. In particular the following assets are transferred accordingly:
 - a) All self-generated or acquired intangible assets, in particular patents, utility and design patents, trademarks, even if these should still be registered in the name of the former company, namely "Heinrich Kipp Werk Spanntechnik + Normelemente" or its occasionally used abbreviated form "Heinrich Kipp Werk", as well as an established clientele.

2. Confirmation of the transfer of the industrial property rights

The spin-off was entered in the commercial register on July 3, 2020. Mr. Heinrich Kipp and ICG GmbH & Co. KG confirm that the industrial property rights listed in the attached **Appendix A** were transferred from Kipp Verpachtungen e.K. to ICG GmbH & Co. KG, and that the transfer of the industrial property rights was with the Goodwill of the business symbolized in the marks and other industrial property rights, and consent that the transfer of said industrial property rights to ICG GmbH & Co. KG is recorded in the registers of the relevant patent and trademark offices.
