**TERMINATION AND RELEASE OF SECURITY INTEREST  
IN TRADEMARKS**

This **TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS**, dated as of July 9, 2021 ("Release"), is made by Cortland Capital Market Services LLC, in its capacity as agent for Lenders (in such capacity, together with its successors and assigns in such capacity, the "Agent") in favor of Smithway Motor Xpress, Inc., an Iowa corporation ("Grantor").

**WHEREAS**, pursuant to that certain Trademark Security Agreement, dated as of February 23, 2015, and recorded at the United States Patent and Trademark Office ("USPTO") on February 23, 2015 at Reel 5464 Frame 0427 (as amended, restated, supplemented, modified, extended, renewed or replaced from time to time, the "Security Agreement"), by and among the Grantor and the Agent, Grantor granted to the Agent a continuing security interest in Grantor's right, title and interest in and to all Trademark Collateral.

**NOW THEREFORE**, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Agent and Grantor agree as follows:

**SECTION 1. Defined Terms.** All capitalized terms used herein but not otherwise defined herein have the meanings given to them in the Security Agreement.

**SECTION 2. Termination and Release.** The Agent without representation, warranty, or recourse, hereby:

(a) terminates, cancels, discharges, and releases the continuing security interest in, and the right to set off against, Grantor's right, title, and interest in and to all Trademark Collateral, including, but not limited to, the foregoing listed on Schedule A attached hereto, granted pursuant to the Security Agreement; and


(b) authorizes the recordation of this Release with the USPTO at Grantor's expense.

**SECTION 3. Choice of Law.** This Release shall be governed by and construed in accordance with the laws of the State of New York.


