**PARTIAL RELEASE OF SECURITY INTEREST IN
TRADEMARK RIGHTS**

THIS PARTIAL RELEASE OF SECURITY INTEREST IN TRADEMARK RIGHTS (this "Partial Release"), dated as of July 9, 2021, is made by U.S. BANK NATIONAL ASSOCIATION, in its capacity as notes collateral agent (in such capacity, the "Notes Collateral Agent") under the Pledge and Security Agreement and the Grant (each as defined below).

WITNESSETH:

WHEREAS, reference is made to (i) that certain First Lien Pledge and Security Agreement, dated as of January 7, 2021 (as amended, restated, supplemented or otherwise modified from time to time, the "Pledge and Security Agreement"), among The E.W. Scripps Company, Scripps Media, Inc. and the other Grantors party thereto (collectively, the "Grantors"), and the Notes Collateral Agent and (ii) that certain Grant of Security Interest Trademarks, dated as of January 7, 2021 (as amended, restated, supplemented or otherwise modified from time to time, the "Grant"), made by the Grantors in favor of the Notes Collateral Agent;

WHEREAS, pursuant to the Pledge and Security Agreement and the Grant, a lien and security interest (the "Security Interest") was granted by the Grantors to the Notes Collateral Agent on and in certain collateral, including the Trademark listed on Schedule A thereto;

WHEREAS, the Grant was recorded in the Trademark Division of the United States Patent and Trademark Office on January 8, 2021 at Reel/Frame 007158/0857.


WHEREAS, the Notes Collateral Agent now desires to terminate and release the Security Interest in the Trademark (and no other Trademarks) listed on Schedule 1 hereto (the "Released Trademark").

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, and upon the terms set forth herein, the Notes Collateral Agent hereby agrees as follows:

1. Definitions. Capitalized terms not defined herein have the meanings set forth in the Pledge and Security Agreement or in the Grant.
2. Release of Security Interest. The Notes Collateral Agent, without representation, warranty or recourse, hereby terminates, releases and discharges the Security Interest in the Released Trademark (and no other Trademarks), and any right, title or interest of the Notes Collateral Agent in the Released Trademark shall hereby cease and become void.
3. Recordation. The Notes Collateral Agent authorizes any of the Grantors and their designees to record this Partial Release with the United States Patent and Trademark Office, or any other applicable governmental authority, at the Grantors' expense.

IN WITNESS WHEREOF, the undersigned has executed and delivered this Partial Release of Security Interest in Trademark Rights by its duly authorized officer as of the date first above written.
